

## THE CUSTOMS DISTRICTS NOTICE 1988

PURSUANT to section 15 of the Customs Act 1966, the Comptroller of Customs hereby gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Customs Districts Notice 1988.
  - (2) This notice shall come into force on the 1st day of April 1988.
- 2. Customs districts—(1) The districts specified in the Schedule hereto are hereby appointed to be districts for the purpose of the control and management of all matters relating to the Customs Acts not otherwise expressly provided for by any other enactment.
- (2) Each of these districts shall comprise the counties, districts, or parts thereof, specified in that behalf in the Schedule hereto, together with all cities, boroughs, and town districts that are within the outer boundaries of those counties, districts, or parts thereof, or are bounded by those counties, districts, or parts thereof, or are between those counties, districts, or any other part thereof and the sea.
  - 3. Revocation—The Customs Districts Notice 1987\* is hereby revoked.

## EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 April 1988, abolishes the Customs District of Wanganui.

The Customs District of New Plymouth is consequentially amended to include Patea and the Customs District of Palmerston North is consequentially amended to include Waitotara, Waimarino, Wanganui, and Rangitikei.

The boundaries of the other Customs Districts are not altered.
