



THE CUSTOMS DISTRICTS NOTICE 1989

PURSUANT to section 15 of the Customs Act 1966, the Comptroller of Customs hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Customs Districts Notice 1989.

(2) This notice shall come into force on the 1st day of December 1989.

2. Customs Districts—(1) The districts specified in the Schedule hereto are hereby appointed to be districts for the purpose of the control and management of all matters relating to the Customs Acts not otherwise expressly provided for by any other enactment.

(2) Each of these Customs districts shall comprise the Districts, Cities, Wards, Counties or parts thereof, specified in that behalf in the Schedule to this notice.

3. Revocation—The Customs Districts Notice 1988* is hereby revoked.
