THE CIVIL DEFENCE REGIONS NOTICE 1983

PURSUANT to section 15 of the Civil Defence Act 1962, the Minister of Civil Defence hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Civil Defence Regions Notice 1983.

(2) This notice shall come into force on the 14th day after the date of its publication in the *Gazette*.

2. Civil defence regions—For the purposes of the Civil Defence Act 1962, New Zealand is hereby declared to be divided into civil defence regions with the names and comprising the districts of the local authorities set out in the Schedule to this notice.
