THE CUSTOMS DUTIES (TIMBER) SUSPENSION ORDER 1956

ORDER IN COUNCIL

At the Government House at Wellington this 27th day of June 1956

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 12 of the Customs Amendment Act 1921, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the existing duties are likely to operate in an injurious manner generally to the public interest, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Customs Duties (Timber) Suspension Order 1956.
- (2) This order shall come into force on the 1st day of July 1956.
2. This order applies to all duties of Customs, including surtax and primage duty, and whether imposed by—
 - (a) The existing Tariff (being the First Schedule to the Customs Acts Amendment Act 1934): or
 - (b) Part I of Schedule XIII to the General Agreement on Tariffs and Trade, as set out in the First Schedule to the General Agreement on Tariffs and Trade Act 1948, as amended by the General Agreement on Tariffs and Trade Order 1950*; or
 - (c) The Second Schedule to the General Agreement on Tariffs and Trade Act 1948, as amended by the General Agreement on Tariffs and Trade Order 1950*; or
 - (d) Schedule B to the Trade Agreement between Canada and New Zealand, as set out in the Appendix to the Trade Agreement (New Zealand and Canada) Ratification Act 1932; or
 - (e) Any other enactment.
3. All duties relating to the goods set out in the Schedule hereto are hereby suspended until the end of December 1957.
4. Every suspension of duty hereby effected shall be subject to the provisions of section 143 of the Customs Act 1913.

5. All duties of Customs that have become due and payable and all penalties and forfeitures that have been incurred before the commencement of this order shall be recovered and enforced as if this order had not been made.

6. The Customs Duties Suspension Order (No. 2) 1956* is hereby revoked.

SCHEDULE

GOODS ON WHICH DUTIES SUSPENDED UNTIL END OF DECEMBER 1957

Tariff Item No.	Goods
404	Timber, rough sawn or <i>rough hewn</i> , viz.: Ex (2) Redwood, Douglas fir and other coniferous, in pieces having a length of not less than 25 ft. and having a minimum cross sectional area of not less than 150 square inches. Ex (3) N.e.i., viz.: Douglas fir and other coniferous.
