## ORDER IN COUNCIL

At the Government House at Wellington this 15th day of November 1971

PURSUANT to section 125 of the Customs Act 1966 and section 5 of the Customs Amendment Act 1971, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

1. Title and commencement—(1) This order may be cited as the Customs Duties (Timber) Suspension Order 1970, Amendment No. 1, and shall be read together with and deemed part of the Customs Duties (Timber) Suspension Order 1970.\*

(2) This order shall come into force on 1 January 1972.

**2. Tariff amended**—The Customs Duties (Timber) Suspension Order 1970\* is hereby amended by revoking the Schedule, and substituting the Schedule set out in the Schedule to this order.

### NEW SCHEDULE TO THE CUSTOMS DUTIES (TIMBER) SUSPENSION ORDER 1970

#### Tariff Item Goods Wood sawn lengthwise, sliced or peeled, but not further prepared, of a thickness exceeding 5mm: Of coniferous species: Sequoia sempervirens (redwood): 44.05.002 In lengths of not less than 25 ft and having a minimum cross-sectional area of not less than 150 sq. in. 44.05.009 Other sizes Pseudotsuga douglasii (Douglas fir, Oregon pine): "Clears" timber in lengths of not less than 25 ft Ex 44.05.011 and having a minimum cross-sectional area of not less than 150 sq. in. Ex 44.05.019 "Clears" timber, other sizes Thuja plicata (western red cedar): 44.05.021 In lengths of not less than 25 ft and having a minimum cross-sectional area of not less than 150 sq. in. 44.05.029 Other sizes
