

THE CUSTOMS DUTIES SUSPENSION ORDER (NO. 7) 1952

At the Government House at Wellington, this 3rd day of December 1952

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 12 of the Customs Amendment Act 1921, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the existing duties are likely to operate in an injurious manner generally to the public interest, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Customs Duties Suspension Order (No. 7) 1952.
- (2) This order shall come into force on the date of its notification in the Gazette.
- **2.** This order applies to all duties of Customs, including surtax, and whether imposed by—
 - (a) The existing Tariff (being the First Schedule to the Customs Acts Amendment Act 1934, as amended by the Customs Tariff Amendment Order 1938, No. 2*); or
 - (b) Part I of Schedule XIII to the General Agreement on Tariffs and Trade, as set out in the First Schedule to the General Agreement on Tariffs and Trade Act 1948; or
 - (c) Schedule B to the Trade Agreement between Australia and New Zealand, as set out in the Appendix to the Trade Agreement (New Zealand and Australia) Ratification Act 1933, as amended by the Trade Agreement (Australia) Order 1938†; or
 - (d) Schedule B to the Trade Agreement between Canada and New Zealand, as set out in the Appendix to the Trade Agreement (New Zealand and Canada) Ratification Act 1932, as amended by the Trade Agreement (Canada) Order 1938;; or
 - (e) Any other enactment.
- **3.** All duties relating to the goods set out in the Schedule hereto are hereby suspended until the 30th day of June 1953.

4. Every suspension of duty hereby effected shall be subject to the

provisions of section 143 of the Customs Act 1913.

5. All duties of Customs that have become due and payable and all penalties and forfeitures that have been incurred before the commencement of this order shall be recovered and enforced as if this order had not been made.

6. The Customs Tariff Amendment Order 1951* is hereby revoked.

EXPLANATORY NOTE

[This note is not part of the order, but is intended to indicate its general effect.]

This order suspends all Customs duties (including surtax) on prefabricated houses of metal or wood until 30 June 1953, and replaces the Customs Tariff Amendment Order 1951, which suspended these duties until 31 December 1952.
