THE CUSTOMS EXPORT PROHIBITION ORDER 1941, NO. 1.

ORDER IN COUNCIL.

At the Government House at Wellington, this 18th day of
June, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 47 of the Customs Act, 1913, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being of opinion that the prohibitions hereinafter enacted are necessary in the public interest and for the purpose of consolidating and amending certain enactments heretofore in force, doth hereby order as follows :—

1. This Order may be cited as the Customs Export Prohibition Order 1941, No. 1.

2. This Order shall come into force on the day following notification in the *Gazette* of the making hereof.*

3. The Orders in Council specified in the following table are hereby revoked so far as not already heretofore revoked :—

4. All consents and permissions which originated under any Order in Council revoked by the Customs Import Prohibition Order 1941, No. 1,† or this Order and are of continuing effect at the time of coming into force of this Order and are of a kind capable of originating under this Order shall enure for the purposes of this Order as if they had originated under this Order and shall where necessary be deemed to have so originated.

5. Any permission given by a Minister under this Order shall be in writing under the hand of the Minister and may relate to any particular transaction or to any series or class of transactions therein described and may be given subject to such conditions and restrictions as the Minister in his discretion thinks fit to impose therein and may at any time by writing under the hand of the Minister given to the person to whom the permission was given be withdrawn or modified.

6. The exportation is prohibited, save with the consent of the Minister of Customs or the Minister of Finance and save as provided by clauses 7, 8 and 9 hereof, of all coin of whatever metal and wherever and whenever minted and whether legal currency in New Zealand or elsewhere or not.

7. It shall be lawful so far as this Order is concerned for any person leaving New Zealand to take with him on his departure from New Zealand an amount of silver coin not exceeding £2 or such larger sum as a Minister may permit.

8. It shall be lawful so far as this Order is concerned for any person leaving New Zealand with the intention of proceeding to Great Britain or Ireland by direct route without transshipment from the vessel in which he leaves New Zealand to take with him an amount of silver coin not exceeding £5 or such larger sum as a Minister may permit.

9. Clause 6 hereof shall not apply to silver coin whether legal tender or not which is more than one hundred years old.

10. The prohibitions contained in this Order shall have effect in addition to and not in substitution for any other prohibition in force relating or applicable to the exportation of any of the goods and articles herein referred to whether contained in this Order or in any other enactment.
