

THE CINEMATOGRAPH FILMS EXHIBITORS' LICENSES EMERGENCY REGULATIONS 1943

C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 4th day of August, 1943

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Cinematograph Films Exhibitors' Licenses Emergency Regulations 1943.

2. In these regulations—

- "The said regulations" means the Cinematograph Films (Storage, Exhibition, and Renting) Regulations 1929*:
- "Board" means the Mutual Film Insurance Board (being an unincorporated Board established by agreement between the Film Exchanges Association of New Zealand, Inc., and the New Zealand Motion Picture Exhibitors' Association of New Zealand, Inc., and having its office in the City of Wellington):
- "Chief Inspector" means the Chief Inspector under the said regulations:
- "Minister" means the Minister of Internal Affairs.

APPLICATION OF THESE REGULATIONS

3. These regulations apply to all exhibitors' licenses and itinerant exhibitors' licenses granted under the said regulations at any time after the 30th day of September, 1942 (whether before or after the commencement of these regulations).

EXTENSION OF LICENSES TO WHICH THESE REGULATIONS APPLY

4. (1) Notwithstanding anything to the contrary in the said regulations or in any license to which these regulations apply, every such license, unless sooner surrendered or revoked in accordance with the said regulations or unless it lapses in accordance with these regulations, shall continue in force until a date to be fixed in that behalf by the Minister by notification published in the *Gazette*.

(2) Any such notification may refer to all licenses to which these regulations apply, or may be limited to specified classes of licenses, or to licenses issued to specified licensees or groups of licensees.

(3) Any notification published by the Minister for the purposes of this clause may in like manner be at any time amended or revoked.

(4) Every licensee whose license is extended pursuant to subclause (1) hereof shall, not later than the 30th day of October in the year 1943, and not later than the corresponding date in each succeeding year thereafter while the license is in force, pay to the Board the appropriate annual license fee as set out in the Second Schedule to the said regulations.

(5) Any license in respect of which the prescribed annual fee is not paid in accordance with the last preceding subclause, or within such extended time as the Chief Inspector may in any case allow, shall be deemed to have lapsed on the last day allowed for payment of the said fee.

5. (1) All moneys received by the Board pursuant to these regulations shall be received in trust by the Board for the purposes for which they were paid and, subject to the next succeeding subclause, shall be forthwith paid by the Board into the Public Account.

(2) From moneys received by it pursuant to these regulations the Board shall be entitled to retain an amount equal to 10 per cent. thereof as remuneration for its services under these regulations.

(3) The Board shall from time to time furnish to the Chief Inspector, in such form as he may require or approve, such particulars as he may require with respect to fees received by the Board and as to payments made by it into the Public Account for the purposes of these regulations. Returns under this subclause in respect of fees received and payments made by the Board in any month shall be made within the first five days of the next succeeding month, but nothing herein shall preclude the Chief Inspector from requiring the Board to furnish additional returns at any time in respect of the fees received or the payments made by it during any specified period.
