PURSUANT to the Companies Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Companies Fees Order 1967.
  - (2) This order shall come into force on the 1st day of January 1968.
- 2. New fees prescribed—(1) The table of fees in the First Schedule to the Companies Act 1955 is hereby amended by revoking Part III (as substituted by clause 2 of the Companies Fees Order 1965), and substituting the new Part III set out in the Schedule to this order.
  - (2) The Companies Fees Order 1965\* is hereby revoked.

# EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order prescribes a new scale of fees payable to the Registrar of Companies under Part III of the First Schedule to the Companies Act 1955. The fee for the first certificate of incorporation, the fee for registering an instrument creating or evidencing a charge, and the fee for supplying a copy of or an extract from a document are all increased. The new scale comes into force on 1 January 1968.
