REVOCATION ORDER 1966**

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of May 1966

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Cook Islands Act 1915, the National Expenditure Adjustment Act 1932, and Part I of the Finance Act 1935, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and, in relation to such of the regulations and orders hereby revoked as are in force in the Cook Islands (other than Niue), at the request and with the consent of the Government of the Cook Islands made and given pursuant to Article 88 of the Constitution of the Cook Islands, hereby makes the following order.

ORDER

1. This order may be cited as the Cook Islands and Niue Regulations Revocation Order 1966.
2. The regulations and orders specified in the Schedule to this order are hereby revoked.
