THE CORONERS' INQUESTS FEES REGULATIONS 1947

ORDER IN COUNCIL

At the Government House at Wellington, this 25th day of
June, 1947

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Coroners Amendment Act, 1920, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Coroners' Inquests Fees Regulations 1947.

2. The regulations made under section 2 of the Coroners Amendment Act, 1920, on the 19th day of October, 1931,* and the Coroners' Fees Amendment Regulations 1937†, are hereby revoked.

3. These regulations shall come into force on the 1st day of July, 1947.

4. The rates of fees and allowances to be payable in respect of inquests held after the coming into force of these regulations shall be as specified in the Schedule hereto.

(a) Attending and giving evidence, when not required to make a <i>post-mortem</i> examination	1	0	0

(b) Performing a <i>post-mortem</i> examination at the direction of the Coroner or Justice holding the inquest, and giving evidence thereof at the inquest	3	3	0

Provided that fees additional to those hereinbefore prescribed may with the approval of the Minister of Justice be paid where in the opinion of the Minister, exceptional circumstances render the payment of such additional fees desirable.

ALLOWANCES

In addition to the fees hereinbefore prescribed, such persons shall be entitled to a refund of the amount of actual expenses of locomotion reasonably incurred in the performance of duties in travelling by rail, coach, or steam-boat, and to receive in respect of any other expenses of locomotion an allowance at the following rates:—

To the Coroner, Deputy Coroner, or Justice of the Peace, other than a Stipendiary Magistrate: At the rate of 1s. per mile, counted one way only.

To a medical practitioner: At the rate of 1s. per mile, counted one way only.
