THE CIVIL LIST (ANNUITIES) DETERMINATION 1994

PURSUANT to section 4 of the Civil List Act 1979 (as amended by section 4 of the Civil List Amendment Act 1985) and to the Higher Salaries Commission Act 1977, the Higher Salaries Commission hereby makes the following determination.

DETERMINATION

- 1. Title and commencement—(1) This determination may be cited as the Civil List (Annuities) Determination 1994.
- (2) This determination shall be deemed to have come into force on the 1st day of April 1994.
- 2. Expiry—This determination shall expire on the 31st day of March 1995.
- **8. Annuity for former Governor-General**—The annuity payable under section 4 (1) of the Civil List Act 1979 to a person who has held office as Governor-General and who was, at the time of that person's appointment, domiciled in New Zealand shall be paid,—
 - (a) If that person held office as Governor-General for a total period of less than 2 complete years, at the yearly rate of \$7,620:
 - (b) If that person held office as Governor-General for a total period of 2 complete years or more, at the yearly rate of \$7,620 for each complete year (not exceeding 5) of that total period.
- 4. Annuity for widow or widower of former Governor-General—The annuity payable under section 4 (2) of the Civil List Act 1979 to the widow or widower of a person who held office as Governor-General and who was, at the time of that person's appointment, domiciled in New Zealand shall be paid,—
 - (a) If that person held office as Governor-General for a total period of less than 2 complete years, at the yearly rate of \$3,810:
 - (b) If that person held office as Governor-General for a total period of 2 complete years or more, at the yearly rate of \$3,810 for each complete year (not exceeding 5) of that total period.

5. Revocation—The Civil List (Annuities) Determination 1993* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 1 April 1994, increases the rate of the annuity payable to a former Governor-General (who was domiciled in New Zealand at the time of appointment) and the rate of the annuity payable to the widow or widower of such a Governor-General.

The rates applying before the date of the commencement of this determination were fixed, as at 1 April 1993, by the Civil List (Annuities) Determination 1993.

In the case of a former Governor-General who held office for a total period of less than 2 complete years, the yearly rate of the annuity is now increased from \$7,480 to \$7,620. In the case of a former Governor-General who held office for a total period of 2 complete

In the case of a former Governor-General who held office for a total period of 2 complete years or more, the sum of \$7,480 payable for each complete year (not exceeding 5) of that total period is now increased from \$7,480 to \$7,620.

In the case of the widow or widower of a person who held office as Governor-General, the increases now effected in the rates of annuities are such that the annuity payable in each case continues to be one half of the annuity that would have been payable to the person who held office as Governor-General.

This determination expires on 31 March 1995.
