

## THE CIVIL LIST (ANNUITIES) DETERMINATION 1996

---

PURSUANT to section 4 of the Civil List Act 1979 (as amended by section 4 of the Civil List Amendment Act 1985) and to the Higher Salaries Commission Act 1977, the Higher Salaries Commission hereby makes the following determination.

---

### DETERMINATION

**1. Title and commencement**—(1) This determination may be cited as the Civil List (Annuities) Determination 1996.

(2) This determination shall be deemed to have come into force on the 1st day of April 1996.

**2. Expiry**—This determination shall expire on the 31st day of March 1997.

**3. Annuity for former Governor-General**—The annuity payable under section 4 (1) of the Civil List Act 1979 to a person who has held office as Governor-General and who was, at the time of that person's appointment, domiciled in New Zealand shall be paid,—

- (a) If that person held office as Governor-General for a total period of less than 2 complete years, at the yearly rate of \$8,100:
- (b) If that person held office as Governor-General for a total period of 2 complete years or more, at the yearly rate of \$8,100 for each complete year (not exceeding 5) of that total period.

**4. Annuity for widow or widower of former Governor-General**—The annuity payable under section 4 (2) of the Civil List Act 1979 to the widow or widower of a person who held office as Governor-General and who was, at the time of that person's appointment, domiciled in New Zealand shall be paid,—

- (a) If that person held office as Governor-General for a total period of less than 2 complete years, at the yearly rate of \$4,050:
- (b) If that person held office as Governor-General for a total period of 2 complete years or more, at the yearly rate of \$4,050 for each complete year (not exceeding 5) of that total period.

**5. Revocation**—The Civil List (Annuities) Determination 1995\* is hereby revoked.

EXPLANATORY NOTE

*This note is not part of the determination, but is intended to indicate its general effect.*

This determination, which is deemed to have come into force on 1 April 1996, increases the rate of the annuity payable to a former Governor-General (who was domiciled in New Zealand at the time of appointment) and the rate of the annuity payable to the widow or widower of such a Governor-General.

The rates applying before the date of the commencement of this determination were fixed, as at 1 April 1995, by the Civil List (Annuities) Determination 1995.

In the case of a former Governor-General who held office for a total period of less than 2 complete years, the yearly rate of the annuity is now increased from \$7,840 to \$8,100.

In the case of a former Governor-General who held office for a total period of 2 complete years or more, the sum of \$7,840 payable for each complete year (not exceeding 5) of that total period is now increased from \$7,840 to \$8,100.

In the case of the widow or widower of a person who held office as Governor-General, the increases now effected in the rates of annuities are such that the annuity payable in each case continues to be one-half of the annuity that would have been payable to the person who held office as Governor-General.

This determination expires on 31 March 1997.
