## THE CITYLINE (NZ) LIMITED VESTING ORDER 1992

# ORDER IN COUNCIL

## At Wellington this 31st day of August 1992

Present:

THE RIGHT HON. J. B. BOLGER PRESIDING IN COUNCIL

PURSUANT to the New Zealand Railways Corporation Restructuring Act 1990, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

## ORDER

1. Title—This order may be cited as the Cityline (NZ) Limited Vesting Order 1992.

2. Interpretation—(1) In this order, unless the context otherwise requires,—

- "The Act" means the New Zealand Railways Corporation Restructuring Act 1990:
- "Agreement" means the agreement dated the 27th day of July 1992 between the Corporation and Wellington City Transport Limited in connection with the sale of the Business to Wellington City Transport Limited; and includes the letter agreement varying that agreement:
- "Book debts" means all trade and other debts, accounts, and bills receivable due to the Corporation in respect of the Business:

- "Business" means the suburban bus services business carried on by the Corporation known as "Cityline Hutt Valley" and "Cityline Auckland"; and includes the ticketing agency business conducted at the Corporation's premises at Waterloo in the Hutt Valley and at Papakura:
- "Closing" means the completion date of the sale and purchase of shares pursuant to the agreement:
- "Company" means Cityline (NZ) Limited:
- "Creditors" means persons who are creditors of the Corporation in the ordinary course of the Business:
- "Employee" means a person employed by the Corporation in connection with the Business and who is referred to in clause 3 (2) (u) of this order:
- "Goodwill" means all goodwill of the Corporation in connection with the Business:
- "Trade names" means the names "Cityline Hutt Valley" and "Cityline Auckland".

(2) Any term or expression that is not defined in this order, but that is defined in the Act, has the meaning given to it by the Act.

**8. Vesting of railways assets and railways liabilities in company**—(1) The railways assets and railways liabilities of the Crown and the Corporation to which this clause applies, being assets and liabilities set out in a list prepared pursuant to section 6 of the Act by the Minister of Finance and the Minister for State Owned Enterprises dated the 19th day of August 1992, shall vest in the Company on the 1st day of September 1992.

(2) This clause applies to—

- (a) All rights and obligations of the Corporation under all contracts and agreements, whether oral or written, entered into in the ordinary and normal course of business for the supply of goods and services to, or in connection with, the Business made between the Corporation and any other person, being rights and obligations which arise or are to be performed or discharged on or after the close of business on the 31st day of August 1992:
- (b) All plant, furniture, and fittings owned by the Corporation and-

(i) Situated at the premises used by the Corporation at the Waterloo Interchange at Lower Hutt and used in connection with the Cityline Hutt Valley business of the Corporation (other than the bus wash attached to the maintenance facility):

(ii) Situated at the premises used by the Corporation in Papakura for the purposes of the Cityline Auckland business of the Corporation and used in connection with that business:

(iii) Situated at the depots in Wainuiomata, Stokes Valley, and Upper Hutt used by the Corporation for the purposes of the Cityline Hutt Valley business of the Corporation and used in connection with that business:

- (c) The automatic ticketing machines owned by the Corporation and used in connection with the Business:
- (d) All of the Corporation's rights and obligations under all software licences granted to the Corporation in connection with the Business:
- (e) All stores owned by the Corporation and held for use in connection with the Business:

- (f) All fuel owned by the Corporation and held for use in connection with the Business:
- (g) All other assets owned by the Corporation and used or held for use in connection with the Business (other than land and buildings and the bus wash attached to the maintenance facility at the Waterloo Interchange at Lower Hutt):

- (p) All the Corporation's rights and obligations under the agency agreement between the operating division of New Zealand Rail Limited, known as Cityrail, pursuant to which the Corporation sells tickets to the public for transport on Cityrail's rail services:
- (q) All the Corporation's rights and obligations under the agency agreement between the Corporation and Newman's Coachlines Limited:
- (r) All the Corporation's rights and obligations under all contracts and agreements, whether express or implied, between the Corporation and persons who sell tickets for travel on the services provided by the Corporation in the course of the Business:

- (s) All the Corporation's rights and obligations under all contracts and agreements, whether oral or written, entered into in the ordinary and normal course of business between the Corporation and other persons, for transportation on the bus services provided by the Corporation in the course of the Business; including the contracts with the Wellington Regional Council and the Auckland Regional Council, and all charter services agreed to be provided by the Corporation in the course of the Business after the closing:
- (t) All the Corporation's rights and obligations under the instrument by way of security granted by the Corporation in favour of the Auckland Regional Council:
- (u) All the Corporation's rights and obligations under every contract of service with, and every award or agreement relating to, the following employees of the Corporation, being rights and obligations which arise or are to be performed or discharged on or after the close of business on the 31st day of August 1992 including obligations which have accrued as at that date:
