Pursuant to section 470 of the Companies Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Companies (Fees) Order 1987.
 - (2) This order shall come into force on the 1st day of July 1987.
- 2. New First Schedule to Companies Act 1955 substituted—The Companies Act 1955 is hereby amended by revoking the First Schedule thereto (as substituted by the Companies Amendment Act 1986) and substituting the First Schedule set out in the Schedule to this order.
- **3.** Amount of goods and services tax included—The fees prescribed in the First Schedule to the Companies Act 1955 (as substituted by clause 2 of this order) are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

This order, which comes into force on 1 July 1987, increases the fees set out in the table of fees in the First Schedule to the Companies Act 1955 and adds a new fee for providing a certificate of incorporation of a company.
