### ORDER IN COUNCIL

PURSUANT to section 470 of the Companies Act 1955, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

1. Title and commencement—(1) This order may be cited as the Companies (Fees) Order 1994.

(2) This order shall come into force on the 1st day of July 1994.

2. New First Schedule to Companies Act 1955 substituted—The Companies Act 1955 is hereby amended by revoking the First Schedule thereto (as substituted by the Companies (Fees) Order 1987), and substituting the First Schedule set out in the Schedule to this order.

**3.** Amount of goods and services tax included—The fees prescribed in the First Schedule to the Companies Act 1955 (as substituted by clause 2 of this order) are inclusive of goods and services tax under the Goods and Services Tax Act 1985. **4. Revocation**—The Companies (Fees) Order 1987\* is hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order substitutes a new First Schedule to the Companies Act 1955.

The First Schedule sets out the fees and annual return fees payable to the Registrar of Companies. The order increases a number of fees, maintains some fees at existing levels, and reduces a number of fees.

The order comes into force on 1 July 1994 and takes into account amendments to the principal Act made by the Companies Amendment Act 1993 and the Financial Reporting Act 1993 which comes into force on that date.
