### ORDER IN COUNCIL

At Wellington this 16th day of March 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 100A of the Judicature Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Court of Appeal Fees Regulations 1987.

(2) These regulations shall come into force on the 1st day of April 1987.

**2. Fees of Court**—(1) The fees specified in the Schedule hereto shall be payable, and shall be taken by the Registrar of the Court of Appeal, in proceedings in that Court in respect of the matters so specified in those cases where no other fee is prescribed in respect of the proceedings by any Act, regulations, Order in Council, or notice.

(2) All such fees shall be prepaid.

**3. Criminal proceedings excluded**—These regulations shall not apply to criminal proceedings.

**4. Revocation**—(1) The Court of Appeal Fees Regulations 1984\* are hereby consequentially revoked.

(2) In respect of any proceedings commenced before the date of the coming into force of these regulations, no further fee shall be payable under the rules hereby revoked, and the appropriate fees, if any, set out in the Schedule hereto shall be payable in respect of any step in the proceedings taken on or after that date.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 April 1987, prescribe a new and increased scale of Court fees payable in respect of civil proceedings in the Court of Appeal.
