ORDER IN COUNCIL

At the Government House at Wellington this 18th day of December 1967

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Judicature Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and with the concurrence of the Right Honourable the Chief Justice and at least four of the other members of the Rules Committee constituted under the Judicature Amendment Act 1930 (of whom at least one was a Judge of the Supreme Court), hereby makes the following rules.

RULES

1. Title and commencement—(1) These rules may be cited as the Court of Appeal Rules 1955, Amendment No. 2, and shall be read together with and deemed part of the Court of Appeal Rules 1955* (hereinafter referred to as the principal rules).

(2) These rules shall come into force on the 1st day of January 1968.

2. New scale of Court fees prescribed—(1) The principal rules are hereby amended by revoking the First Schedule, and substituting the new First Schedule set out in the Schedule to these rules.

(2) The new First Schedule substituted by this rule shall apply in respect of any proceedings commenced on or after the date of the coming into force of these rules.

(3) In respect of any proceedings commenced before the date of the coming into force of these rules, no further fee shall be payable under the Schedule hereby revoked, and the appropriate fees, if any, set out in the new First Schedule substituted by this rule shall be payable in respect of any step in the proceedings taken on or after that date.
