**THE CINEMATOGRAPH OPERATORS LICENSING
REGULATIONS 1938, AMENDMENT NO. 2.**

ORDER IN COUNCIL.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Cinematograph Films Act, 1928, as amended by section 18 of the Statutes Amendment Act, 1936, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Cinematograph Operators Licensing Regulations 1938, Amendment No. 2.

2. These regulations shall be read together with and form part of the Cinematograph Operators Licensing Regulations 1938* (hereinafter called the principal regulations).

3. Clause 11 of the principal regulations is amended by adding to the description of licenses of Grade "B" the following additional paragraph :—

"(iv) For the purposes of an Itinerant Exhibitor's License on less than six but more than two nights a week :"

4. Clause 11 of the principal regulations is further amended by revoking the descriptions of licenses of Grade "C," Grade "D," and Grade "E," and substituting the following :—

"Grade 'C' : A license authorizing the holder to carry on the projection of cinematograph film either for the purposes of an Itinerant Exhibitor's License on less than three nights a week or in any theatre where exhibitions are regularly given on less than three nights a week.

"Grade 'D' : Assistant operator."

5. Any person who at the date of coming into force of these regulations is the holder of a Grade "D" License or a Grade "E" License heretofore issued shall henceforth be deemed to be the holder respectively of a Grade "C" License or a Grade "D" License and shall on application to the Board in that behalf and on surrender of the license theretofore held be entitled to receive a document evidencing him to be the holder of a Grade "C" License or a Grade "D" License, as the case may be.

6. Clause 12 of the principal regulations is amended by revoking all the words thereof after the words "practical experience as follows", and substituting the following words:—

"For Grade 'A' License: Either five years as an assistant operator employed at not less than six exhibitions a week; or four years as an assistant operator employed at not less than nine exhibitions a week; or two years in continuous service employed at not less than three exhibitions a week as the holder of Grade 'B' License:

"For Grade 'B' License: Either three years as an assistant operator employed at not less than three exhibitions a week or as a holder of Grade 'C' License for two years' continuous service or alternatively two years as operator prior to the commencement of these regulations:

"For Grade 'C' License: Either twelve months as an assistant operator employed at not less than one exhibition a week or twelve months as operator prior to the commencement of these regulations:

"Provided that the scope and difficulty of any examination to which this clause relates may be modified according to the grade of license applied for."

7. Clause 17 of the principal regulations is amended by prefixing "(1)" to the text thereof, and by adding thereto the following additional subclause:—

"(2) Every applicant for a license of any grade who is already the holder of a license of that grade and whose application is made in view of the expiration of the license already held shall make his application not less than one month before the day on which he desires the license applied for to take effect."

8. Clause 18 of the principal regulations is amended by revoking the words "Grade 'C' or Grade 'D'" contained in subclause (b) thereof, and substituting the words "or Grade 'C'".
