THE CLOSING OF SHOPS (LATE NIGHT) EMERGENCY **REGULATIONS 1942, AMENDMENT NO. 2**

At the Government House at Wellington, this 29th day of July, 1942.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Closing of Shops (Late Night) Emergency Regulations 1942, Amendment No. 2, and shall be read together with and deemed part of the Closing of Shops (Late Night) Emergency Regulations 1942* (hereinafter referred to as the principal regulations).

2. (1) Clause 4 of the principal regulations is hereby amended by revoking subclause (2) thereof (as set out in clause 2 of the Closing of Shops (Late Night) Emergency Regulations 1942, Amendment No. 1)[†], and substituting the following subclause :-

"(2) By the same or another like notice any local authority that has fixed the closing-time to be observed by any shop or shops on the late night may with the approval of the Minister, and if so directed by the Minister shall, authorize the occupier of any such shop to keep the shop open and to employ assistants during such time or times as may be specified by the local authority, being :---

(a) Before the ordinary opening-time on the day for which the closing-time has been fixed as aforesaid; or

- "(b) Before the ordinary opening-time or after the ordinary closing-time on any other day; or
- "(c) Partly before the ordinary opening-time on any such day, and partly after the ordinary closing-time on any day except the day for which the closing-time has been fixed as aforesaid:

"Provided that the total length of time during which the shop may be kept open or any assistants may be employed in any week shall not exceed the total length of time during which the shop could have been kept open or such assistants have been employed during that week if the closing-time on the late night had not been altered."

(2) The Closing of Shops (Late Night) Emergency Regulations 1942, Amendment No. 1,* is hereby revoked.

(3) Any authority heretofore given pursuant to the regulations hereby revoked, and subsisting on the coming into force of these regulations, shall have the same force and effect and shall continue to operate as if it had been given under these regulations.
