THE CUSTOMS PRIMAGE (YARNS) EXEMPTION ORDER 1960

ORDER IN COUNCIL

At the Government Buildings at Wellington this 21st day of November
1960

Present:

THE RIGHT HON. W. NASH, C.H., PRESIDING IN COUNCIL

PURSUANT to section 4 of the Customs Acts Amendment Act 1931,
His Excellency the Governor-General, acting by and with the advice
and consent of the Executive Council, hereby makes the following order.

ORDER

1. (1) This order may be cited as the Customs Primage (Yarns)
Exemption Order 1960.

(2) This order shall be deemed to have come into force on the
22nd day of July 1960.

2. The classes of goods set out in the First Schedule hereto are
hereby exempted from the primage duty imposed by section 4 of the
Customs Acts Amendment Act 1931.

3. (1) The Customs Primage Order 1937, No. 1,* is hereby con-
sequentially amended by omitting from the Schedule the words "and
yarn".

(2) The Customs Primage Exemption Order 1949† is hereby amended
by revoking so much of the Schedule as relates to cotton yarn.

4. The Orders in Council specified in the Second Schedule hereto are
hereby consequentially revoked.

SCHEDULES

FIRST SCHEDULE

GOODS EXEMPTED FROM PRIMAGE DUTY

Tariff Item No.	Classes of Goods
Ex 192	Yarns of cotton, on declaration by a manufacturer that they will be used by him only in the manufacture of electrodes for electric welding, or of sewing cottons, or of tubular woven or knitted cotton cloth specially suited for use as meat wraps.
Ex 192	Yarns of cotton, silk, <i>man-made fibres</i> , or mixtures of the foregoing, on declaration by a manufacturer that they will be used by him only in the manufacture of elastics, tape, webbings, or petershams, or of woven labels for apparel or for similar articles.
Ex 192	Yarns of rayon, on declaration by a manufacturer that they will be used by him only in the manufacture of warp-knit fabrics.
