THE CREAM PRICE NOTICE 1968, AMENDMENT NO. 3

Pursuant to the Milk Act 1967, the Minister of Agriculture and Fisheries hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Cream Price Notice 1968, Amendment No. 3, and shall be read together with and deemed part of the Cream Price Notice 1968* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 1st day of September

1973.

- 2. Schedule to principal notice revoked—The principal notice is hereby amended by revoking the Schedule, and substituting the Schedule hereto.
- 3. Consequential revocation—The Cream Price Notice 1968, Amendment No. 2, is hereby revoked.

The new maximum price is subject, however, to special allowances and special prices notified by the New Zealand Milk Board pursuant to section 25 (5) of the Milk Act 1967.
