# THE CHRISTCHURCH POST-PRIMARY SCHOOLS BOARDS **OF GOVERNORS REGULATIONS 1954**

#### ORDER IN COUNCIL

At the Government House at Wellington, this 9th day of June 1954

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 7 of the Education Amendment Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. These regulations may be cited as the Christchurch Post-primary Schools Boards of Governors Regulations 1954.

2. In these regulations, unless the context otherwise requires,-"Governor" means a Governor appointed or elected under these regulations:

- "Minister" means the Minister of Education: "Parent of a Pupil" includes both the father and the mother of a pupil, and also includes a pupil's guardian, and a householder with whom a pupil resides, but does not include a parent with whom a child does not normally reside:
- "Returning Officer" means a Returning Officer appointed under these regulations:
- "School" means a school to which these regulations apply.
- 3. These regulations shall apply to the following schools, namely—
  (a) The Christchurch Boys' High School:
  (b) The Christchurch Girls' High School:
  (c) The Avonside Girls' High School:
  (d) The Christchurch West High School:
  (e) The Linwood High School:
  (f) The Denermi Technical School:

  - (f) The Papanui Technical School.

4. (1) The Board of Governors of each of the following schools, namely, the Christchurch Boys' High School, the Christchurch Girls' High School, the Avonside Girls' High School, the Christchurch West High School, and the Linwood High School, shall consist of—

- (a) One Governor appointed by the Governor-General:
- (b) One Governor appointed by the Canterbury Education Board:
- (c) Two Governors appointed by the Canterbury University College Council:
- (d) Two Governors appointed by the Old Pupils' Association:
- (e) Three Governors elected by the parents of the pupils attending the school, of which Governors at least one shall be a woman in the case of the Christchurch Girls' High School, the Avonside Girls' High School, the Christchurch West High School, and the Linwood High School.

(2) Until an Old Pupils' Association of the Linwood High School is formed, the two Governors to be appointed to the Board of Governors of that school under paragraph (d) of subclause (1) of this regulation shall be appointed by the Parent-Teacher Association of the school; and all the provisions of these regulations relating to appointments by the Old Pupils' Association of the school shall apply so far as they are applicable and with the necessary modifications to appointments by the Parent-Teacher Association of the school.

5. (1) The Christchurch Post-primary Schools Council shall fix the date for the first election of Governors to represent the parents of the pupils of the Linwood High School and the month in which the Canterbury Education Board, the Canterbury University College Council, and the Parent-Teacher Association of the Linwood High School shall hold a meeting to appoint Governors in accordance with these regulations.

(2) The Governors of the Linwood High School appointed or elected in accordance with these regulations in the year 1954 shall hold office until the election or appointment of Governors is completed in the year 1955 in accordance with these regulations.

6. The Board of Governors of the Papanui Technical School shall consist of-

- (a) One Governor appointed by the Canterbury Education Board:
- (b) One Governor appointed by the Canterbury University College Council:
- (c) One Governor appointed by the Old Pupils' Association of the school:
- (d) Three Governors elected by the parents of the pupils attending the school, of which Governors at least one shall be a woman:
- (e) One Governor appointed by the Christchurch City Council and the Waimairi County Council:
- (f) Two Governors elected by the associations of employers in local industries:
- (g) Two Governors elected by the associations of employees in local industries:

7. (1) Except as otherwise provided in these regulations, the term of office of every Governor shall be three years, but every Governor shall, unless disqualified as hereinafter provided, continue in office until the appointment or election of his or her successor in office.

(2) The powers of the Board of Governors of any school shall not be affected by any vacancy in the membership thereof.

8. The Christchurch Post-primary Schools Council shall appoint a Returning Officer for each election.

9. (1) The appointment of Governors to represent the Canterbury Education Board, the Canterbury University College Council, and the Old Pupils' Association of each school shall be made by resolution passed by the body entitled to make the appointment at a meeting held in the month of March in the year 1955, and in that month in every third year thereafter, and conveyed to the Returning Officer before the 1st day of April following the meeting.

(2) The appointment of a Governor to represent the Christchurch City Council and the Waimairi County Council on the Board of Governors of the Papanui Technical School shall be made by a resolution passed by each of the Councils at a meeting held in the month of March in the year 1955, and in that month of every third year thereafter, and conveyed to the Returning Officer before the 1st day of April following the meeting.

10. (1) In the case of each of the following groups of electing bodies, namely—

(a) The associations of employers in local industries; and

(b) The associations of employees in local industries,—

an electing committee shall be constituted from time to time in accordance with this regulation.

(2) Every Electing Committee shall meet when convened by the Returning Officer, and shall in March in the year 1955, and in that month of every third year thereafter, elect on behalf of the group of bodies concerned the number of representatives required in respect of that group in such manner as it deems fit.

(3) Each local association of employers or employees recognized thereto by the Minister shall be entitled to appoint one member of the Electing Committee for the relative group of electing bodies.

(4) Every Council and association which appoints a member of an Electing Committee shall give notice in writing to the Returning Officer as soon as reasonably possible thereafter of the name and address of the person appointed.

(5) In the month of February in the year 1955, and in that month in every third year thereafter, the Returning Officer shall give notice by advertisement in a newspaper circulating in the City of Christchurch of the intention to hold meetings of the said Electing Committees in the following month. The notice shall call for applications from associations of employers and employees to be recognized by the Minister for the purpose of sending a representative to meetings of the relative Electing Committee.

(6) The Returning Officer shall act as secretary to each of the Electing Committees and shall convene a meeting of the Committee whenever necessary for the purposes of these regulations.

11. (1) The election of Governors by the parents of pupils attending each school shall be held in the month of March in the year 1955, and in that month in every third year thereafter.

(2) In the month of February in the year 1955, and in that month in every third year thereafter, the Returning Officer shall prepare a roll and shall enter therein the name and address of every person qualified to be enrolled as a parent of a pupil of the school. The roll shall be closed at 5 p.m. on the fourteenth day before the day on which any election under this regulation is to be held, and shall continue to be closed until the election is completed.

(3) An advertisement relating to the election shall be published in a newspaper circulating in the City of Christchurch not less than twenty-one days before the date of the election, and shall contain—

(a) The day and hour for the closing of nominations:

(b) The number of Governors to be elected:

(c) The day and hour for the closing of the election.

(4) Every candidate shall be nominated in writing by one or more parents entitled to vote for his election.

(5) Every nomination paper shall be in the form or to the effect following:

(6) If the nomination paper does not bear the written consent of the candidate nominated, that consent may be given by him to the Returning Officer before the nominations are closed, and every nomination paper shall be void in so far as it concerns any candidate whose written consent is not duly given as aforesaid.

(7) Nominations shall close at noon on the fourteenth day before the day of election.

(8) If the number of nominations does not exceed the number of vacancies to be filled and the number of men candidates does not exceed the number of vacancies that can be filled by men, the Returning Officer shall forthwith declare the candidates so nominated to be duly elected. If the number of candidates exceeds three he shall, as soon as the nominations are closed, prepare and post to each elector at his address as appearing on the roll a voting paper containing in alphabetical order of surnames a list of all the duly nominated candidates, which voting paper shall be in the form or to the effect following:

Candidates [Set out in alphabetical order of surnames the full name of every duly nominated candidate]

#### Directions

The voter is required to cross out the name or names of the candidate or candidates for whom he does not desire to vote. The number of vacancies is \_\_\_\_\_\_, of which \_\_\_\_\_ cannot be filled by a man. The vote will therefore be informal if the names of at least \_\_\_\_\_\_ men, or at least \_\_\_\_\_\_ men and women, are not crossed out. The voting paper must be enclosed by the voter in a sealed envelope bearing on the inside the signature of the voter, and on the outside thereof the words "Voting paper", and if posted to the Returning Officer must be posted on or before the day of the election, or if delivered to him shall be delivered at his office at \_\_\_\_\_\_ before the day of the election or not later than 5 o'clock on the afternoon of that day.

(9) The poll shall close at 5 o'clock on the afternoon of the day of the election, but all voting papers shall be included and counted which are not informal and are received by the Returning Officer in due course of post before the close of the third day after the day of the election.

(10) A voting paper shall be informal in any of the following cases, that is to say:

- (a) If the envelope in which it is forwarded to the Returning Officer is not duly signed by the parent; or
- (b) If the number of candidates whose names are not crossed out exceeds the total number of candidates for whom the person is entitled to vote, or the number of male candidates whose names are not crossed out exceeds the number of male candidates for whom the person is entitled to vote, or if in any other way the paper fails to indicate clearly for whom the vote is intended to be given; or
- (c) If, being delivered to the Returning Officer, the sealed envelope containing the voting paper is not delivered at his office before the close of the poll; or
- (d) If, having been forwarded by post, the sealed envelope containing the voting paper is not received at the office of the Returning Officer before the close of the third day after the day of the election; or if, from the post mark on the envelope or otherwise, the Returning Officer is satisfied that it was not posted until after the day of the election.

(11) On the fourth day after the day of the election the Returning Officer shall open and examine all voting papers duly delivered to him or received by him through the post as aforesaid, and after rejecting all informal voting papers shall prepare a list of the candidates placed in the order of the numbers of votes received by them respectively. Any candidate shall have the right to appoint a scrutineer to watch on his behalf the opening and examination of voting papers and to check the counting thereof.

(12) If of the three candidates who have received the greatest number of votes one at least is a woman, the Returning Officer shall declare these three to be elected; but if none of these three candidates is a woman the Returning Officer shall declare the two men candidates who have received the greatest numbers of votes, and the woman candidate who has received the greatest number of votes among the women candidates, to be elected: Provided that if there is no woman candidate the Returning Officer

Provided that if there is no woman candidate the Returning Officer shall declare the two candidates who have received the greatest numbers of votes to be elected. (13) If, by reason of an equality of votes given for two or more candidates, the election is not complete, the Returning Officer shall decide by lot, in the presence of two other persons, which candidate or candidates shall be elected, and thereby complete the election.

(14) If any dispute or question arises touching the regularity of any election, the dispute shall be determined by the Director of Education, whose decision shall be final.

12. Within fourteen days after the election of or the appointment of a Governor the Returning Officer shall forward to the Minister a notification of the name and address of the Governor.

13. Every Governor elected or appointed under these regulations shall come into office upon his election or appointment.

14. In any case in which an election or an appointment of Governors as hereinbefore provided has not been held or made, the Minister may, in his discretion, fix a time and place for the election or the appointment of the Governors, and the foregoing provisions of these regulations shall thereupon be observed, so far as they are applicable and with the necessary modifications, as if the time and place for the election or appointment had been fixed as therein provided; or, in the alternative, in any such case the Minister, in his discretion, may appoint a Governor or Governors to fill the vacancy or vacancies.

15. No person shall be eligible to become or remain a member of the Board of Governors of any school if he is an alien or a mentally defective person, or a bankrupt who has not obtained his discharge or whose discharge is for the time being suspended or is subject to conditions not yet fulfilled, or if he has been convicted of any offence punishable by death or with imprisonment with hard labour for three years or upwards unless he has received a free pardon or has served his sentence or has otherwise suffered the penalty imposed upon him.

16. If any Governor dies or resigns his office by writing under his hand addressed to the Secretary of the Board of Governors or is absent without leave from the meetings of his Board for three consecutive months or while holding office becomes ineligible to remain a member under regulation 15 of these regulations, his office shall be thereby vacated and a casual vacancy shall be deemed to exist.

17. Every person elected or appointed to a casual vacancy shall hold office for the remainder of the term of office of the Governor whom he replaces.

18. Every casual vacancy shall be filled in the same manner and by the same appointing or electing authority as appointed or elected the Governor who is replaced.

**19.** The following regulations are hereby revoked:

#### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations consolidate and amend the regulations which constitute the Boards of Governors of the Christchurch post-primary schools which are under the Christchurch Post-primary Schools Council. The amendments are made for the purpose of extending the regulations to the Linwood High School.
