# THE CHRISTCHURCH POST-PRIMARY SCHOOLS BOARDS OF GOVERNORS REGULATIONS 1954, AMENDMENT NO. 4

## COBHAM, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 13th day of July 1960

### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 7 of the Education Amendment Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. These regulations may be cited as the Christchurch Post-primary Schools Boards of Governors Regulations 1954, Amendment No. 4, and shall be read together with and deemed part of the Christchurch Post-primary Schools Boards of Governors Regulations 1954\* (hereinafter referred to as the principal regulations).

2. Regulation 3 of the principal regulations, as heretofore amended, is hereby further amended by adding the following paragraphs:

"(j) The Aranui High School:

"(k) The Burnside High School."

**3.** (1) Subclause (1) of regulation 4 of the principal regulations, as heretofore amended, is hereby further amended by omitting the words "and the Riccarton High School" in each case where they occur, and substituting in each case the words, "the Riccarton High School, the Aranui High School, and the Burnside High School".

(2) Regulation 4 of the principal regulations, as heretofore amended,
is hereby further amended by adding the following subclause:
"(6) Until the formation of an Old Pupils' Association of each of the

"(6) Until the formation of an Old Pupils' Association of each of the following schools, namely, the Aranui High School and the Burnside High School, the two Governors to be appointed to the Board of Governors of the school under paragraph (d) of subclause (1) of this regulation shall be co-opted by the Board itself; and all the provisions

of these regulations relating to appointments by the Old Pupils' Association of the school shall apply so far as they are applicable and with the necessary modifications to appointments so made in each case by the Board itself."

4. Regulation 5 of the principal regulations, as heretofore amended, is hereby further amended by adding the following subclauses:

"(9) The Christchurch Post-primary Schools Council shall fix a date in the year 1960 for the first election of Governors to represent the parents of the pupils of the Aranui High School and the parents of the pupils of the Burnside High School, and the month in that year in which the Canterbury Education Board and the Council of the University of Canterbury shall, at a meeting, appoint Governors to the Aranui High School Board of Governors."

"(10) Except as otherwise provided in these regulations, every Governor of the Aranui High School and of the Burnside High School appointed or elected in accordance with these regulations in the year 1960 shall hold office until the appointment or election of his successor is completed in the year 1964 in accordance with these regulations."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The Aranui High School and the Burnside High School are being brought under the control of the Christchurch Post-primary Schools Council, and these regulations consequentially extend the Christchurch Post-primary Schools Boards of Governors Regulations 1954 to those schools.
