

THE CHRISTCHURCH POST-PRIMARY SCHOOLS BOARDS OF GOVERNORS REGULATIONS 1954, AMENDMENT NO. 5

COBHAM, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington this 13th day of November 1961

Pursuant to section 7 of the Education Amendment Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Christchurch Post-Primary Schools Boards of Governors Regulations 1954, Amendment No. 5, and shall be read together with and deemed part of the Christchurch Post-Primary Schools Boards of Governors Regulations 1954* (hereinafter referred to as the principal regulations).
- 2. Regulation 3 of the principal regulations, as heretofore amended, is hereby further amended by adding the following paragraphs:
 - "(l) The Hillmorton High School:
 - "(m) The Mairehau High School."
 - 3. The principal regulations are hereby amended by inserting, after

regulation 4, the following regulation:

- "4A. (1) The Board of Governors of each of the following schools, namely, the Hillmorton High School and the Mairehau High School, shall consist of:
 - "(a) One Governor appointed by the Canterbury Education Board:
 - "(b) Two Governors appointed by the Council of the University of Canterbury:
 - "(c) Two Governors appointed by the Old Pupils' Association of the school:
 - "(d) Four Governors elected by the parents of the pupils attending the school, of which Governors at least one shall be a woman.

- "(2) Until the formation of an Old Pupils' Association of each of the following schools, namely, the Hillmorton High School and the Mairehau High School, the two Governors to be appointed to the Board of Governors of the school under paragraph (c) of subclause (1) of this regulation shall be co-opted by the Board itself; and all the provisions of these regulations relating to appointments by the Old Pupils' Association of the school shall apply so far as they are applicable and with the necessary modifications to appointments so made in each case by the Board itself."
- 4. Regulation 5 of the principal regulations, as heretofore amended, is hereby further amended by adding the following subclauses:
- "(11) The Christchurch Post-primary Schools Council shall fix a date in the year 1961 for the first election of Governors to represent the parents of the pupils of the Hillmorton High School and the parents of the pupils of the Mairehau High School, and the month in that year in which the Canterbury Education Board and the Council of the University of Canterbury shall, at a meeting, appoint Governors to the Hillmorton High School Board of Governors and to the Mairehau High School Board of Governors."
- "(12) Except as otherwise provided in these regulations, every Governor of the Hillmorton High School and the Mairehau High School appointed or elected in accordance with these regulations in the year 1961 shall hold office until the appointment or election of his successor is completed in the year 1965 in accordance with these regulations."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The Hillmorton High School and the Mairehau High School are being brought under the control of the Christchurch Post-primary Schools Council, and these regulations consequentially extend the Christchurch Post-Primary Schools Boards of Governors Regulations 1954 to those schools.
