## THE CORONERS REGULATIONS 1952, AMENDMENT NO. 10

## ORDER IN COUNCIL

At the Government House at Wellington this 18th day of July 1977

## HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Coroners Act 1951, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Coroners Regulations 1952, Amendment No. 10, and shall be read together with and deemed part of the Coroners Regulations 1952\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day 2 months after the date of their notification in the *Gazette*.

2. Depositions of witnesses and finding of Coroner—(1) The principal regulations are hereby amended by revoking regulation 10 (as substituted by regulation 3 of the Coroners Regulations 1952, Amendment No. 4), and substituting the following regulation:

"10. On the completion of an inquest, a Coroner shall notify the Secretary in the Form No. 7 in the Schedule hereto of all depositions under the Act taken by a Justice or a Coroner and shall on the same form sign his finding in respect of the inquest and shall forward the form together with the depositions and, where applicable, a certificate of registration of the death to the Secretary."

(2) The Coroners Regulations 1952, Amendment No. 4, are hereby amended by revoking regulation 3.

3. Forms—The Schedule to the principal regulations is hereby amended by revoking Forms numbered 3 and 7, and substituting the forms with the corresponding numbers set out in the Schedule to these regulations.
