## ORDER IN COUNCIL

At the Government House at Wellington this 12th day of June 1978

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Companies Act 1955, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Companies Regulations 1956, Amendment No. 5, and shall be read together with and deemed part of the Companies Regulations 1956\* (hereinafter referred to as the principal regulations).
  - (2) These regulations shall come into force on the 1st day of July 1978.
- 2. New form for declaration of non-disclosure pursuant to section 9A of the Act—(1) The Schedule to the principal regulations is hereby amended by revoking form 19 (as substituted by regulation 7 (1) of the Companies Regulations 1956, Amendment No. 4), and substituting the new form 19 set out in the Schedule to these regulations.
- (2) Regulation 7 of, and the Second Schedule to, the Companies Regulations 1956, Amendment No. 4, are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations substitute a new form 19 (declaration of non-disclosure pursuant to section 9A of the Companies Act 1955) in the Schedule to the Companies Regulations 1956. This amendment is consequential upon the Companies Amendment Act 1977.

Issued under the authority of the Regulations Act 1936. Date of notification in Gazette: 15 June 1978.
