## THE COPYRIGHT (CUSTOMS) REGULATIONS 1963

# BERNARD FERGUSSON, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 5th day of June 1963

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Copyright Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the Copyright (Customs) Regulations 1963.
  - 2. In these regulations—
  - (a) "The Act" means the Copyright Act 1962:
  - (b) Expressions defined in the Act have the meaning so defined.
- 3. (1) The notice required by subsection (1) of section 29 of the Act shall be in form No. 1 or form No. 2 set out in the Schedule hereto.
- (2) A separate notice in the said form No. 1 shall be given in respect of each work.
- (3) A separate notice in the said form No. 2 shall be given in respect of each importation, whether of one or more works.
- 4. Where the owner of the copyright in any published literary, dramatic, or musical work, or any published edition of such a work, or in any published artistic work has given such a notice, he shall notify the Minister of Customs in writing of any change in ownership or other change affecting the notice, within 28 days after the date of the change, and further notice shall be given as the Minister may require. On a change of ownership, whether notified to the Minister or not, any notice already given shall be deemed to have been withdrawn as from the expiry of 28 days from the date of the change of ownership.
- 5. The owner of the copyright in any work or edition, or any agent of his, who gives notice shall (in addition to the evidence furnished in the statutory declaration prescribed in clause 3) furnish to the Minister such further relevant evidence and information within such time and in such form as the Minister may require, and shall produce within such time as the Minister may specify such relevant books or other documents as he may require. If the further evidence and information

so required are not furnished, or if the books or other documents so required are not produced, as so required, the notice shall be deemed to have been withdrawn as from such time as the Minister shall specify.

6. The owner of the copyright in any work or edition, or any agent of his, who gives any such notice shall give to the Minister security or further security, within such time and in such manner as the Minister may require, against all actions, proceedings, claims, and demands whatsoever which may be taken or made against, or costs and expenses which may be incurred by, him in consequence of detention of any copy to which the notice relates. The security or further security shall be given at the time the notice is given or at such other time as the Minister may require. If the security or further security is not given within the time or in the manner required by the Minister, the notice shall be deemed to have been withdrawn as from the expiry of the time so required.

7. In every case—

- (a) In which the Minister of Customs has not required the security or further security referred to in regulation 6 hereof to be given; or
- (b) In which the Minister has taken security and that security is insufficient; or

(c) In which the notice is deemed to have been withdrawn under any of the provisions of regulations 4 to 6 hereof—

the owner of the copyright in any work or edition, and any agent of his, who has given notice shall jointly and severally keep the Minister indemnified against all actions, proceedings, claims, and demands whatsoever which may be taken or made against him, and shall repay to the Minister all costs and expenses which may be incurred by him in consequence of the detention of, or anything done in relation to, any copy of the work or edition to which the notice related. Any such costs, expenses, damages, or other sums may be recovered as a debt due to the Crown.

8. The following regulations are hereby revoked:

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations govern matters which, by section 29 of the Copyright Act 1962, are left to be prescribed in connection with the provisions under which the owner of the copyright may give notice in writing to the Minister of Customs restricting the importation of copies of a work or edition.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 6 June 1963. These regulations are administered in the Customs Department.
