## ORDER IN COUNCIL

At the Government Buildings at Wellington this 7th day of November 1983

Present:

THE RIGHT HON. D. MACINTYRE PRESIDING IN COUNCIL

PURSUANT to section 34 of the Decimal Currency Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title—These regulations may be cited as the Coinage Regulations 1967, Amendment No. 13, and shall be read together with and deemed part of the Coinage Regulations 1967\* (hereinafter referred to as the principal regulations).

2. 1983 Dollar Coin—(1) Notwithstanding anything in regulation 2 (a) of the principal regulations, the design for the one-dollar coin commemorating the 50th anniversary of New Zealand's coinage to be made and issued pursuant to section 10 (1) of the Decimal Currency Act 1964, shall be as follows:

- (a) For the obverse impression, the effigy of Her Majesty the Queen in profile wearing a diamond tiara of festoons, scrolls, and colletspikes, and around the periphery of the coin the inscriptions "ELIZABETH II" to the left of the effigy and "NEW ZEALAND" to the right of the effigy, with the date "1983" below the effigy:
- (b) For the reverse impression, the Coat of Arms of New Zealand with the words "ONE DOLLAR" immediately below the Coat of Arms. Around the periphery of the coin and above the Coat of Arms the inscription "1933 NEW ZEALAND COINAGE 1983" and below the words "ONE DOLLAR" the reverse impressions of 5 former and 4 current coins of New Zealand overlapping each other, the 5 former coins being the half-crown, the florin, the shilling, the threepence, and the sixpence, and the 4 current coins being the 2-cents, the 10-cents, the 20-cents, and the 50-cents coins.

(2) Except as aforesaid, all the provisions of the principal regulations relating to the one-dollar coin shall apply to the coin referred to in subclause (1) of this regulation.

#### EXPLANATORY NOTE

#### This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Coinage Regulations 1967 and prescribe the design for a dollar coin to be issued in 1983 commemorating the 50th anniversary of New Zealand's coinage. The design is illustrated below, with the Machin design used for the effigy of Her Majesty.
