

THE CHIROPODISTS REGULATIONS 1967, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Medical and Dental Auxiliaries Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Chiropodists Regulations 1967, Amendment No. 3, and shall be read together with and deemed part of the Chiropodists Regulations 1967* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of January 1975.
- 2. Interpretation—Regulation 2 of the principal regulations is hereby amended—

(a) By inserting, after the definition of the term "the Act", the following definition:

"'Advertising' means using written words, symbols, or pictures, in any manner whatsoever, so as to bring to the notice of any particular person or class of persons, or of the public, the fact that the services of a chiropodist are available; and 'advertisement' has a corresponding meaning:":

(b) By revoking the definition of the term "material date".

3. Unqualified persons undertaking chiropody—Regulation 6 of the principal regulations is hereby amended by omitting from paragraph (b) the words "control and instructions", and substituting the words "direct supervision".

4. Misconduct—The principal regulations are hereby further amended

by inserting, after regulation 6, the following regulation:

"6A. (1) It is hereby declared that advertising by a chiropodist shall be improper conduct for the purposes of Part III of the Act unless—

"(a) The form and the terms of the advertisement; and

"(b) The means and the occasions of the advertising—

are approved by the Board.

- "(2) The Board may grant its approval for the purposes of subclause (1) of this regulation either generally or in respect of a particular case.
- "(3) Nothing in this regulation limits the meaning of paragraph (b) of subsection (1) of section 27 of the Act."
- 5. Schedule—The Schedule to the principal regulations is hereby amended by revoking Form 1, and substituting the form in the Schedule to these regulations.

APPLICATION FOR REGISTRATION AS CHIROPODIST

(Note: When completing this form, strike out words which do not apply.) To the Secretary, Chiropodists Board, Wellington.

PART A

I hereby apply for registration as a chiropodist on the grounds that—
(a) I was on 1 April 1968 a member of the New Zealand Society of Chiropodists Incorporated; or

(b) I was principally and regularly engaged in chiropody for the period of 3 years immediately preceding 1 April 1968; or

(c) I am registered (or possess sufficient qualifications for registration) as a state registered chiropodist in the United Kingdom; or

(d) I have successfully completed a course of training substantially equivalent to the course of training required for registration as a state registered chiropodist in the United Kingdom; or

(e) I have undergone training in chiropody for a period of 3 years from the day of 19 (being a date after 2 October 1965) to the day of 19 (being a date before 1 December 1969), and have achieved an adequate standard of competence therein; or

(f) I have undergone a course of training, and have passed an examination(s), referred to in regulation 4 (1) (f) of the

Chiropodists Regulations 1967; or

(g) I have undergone a course of training, and have passed an examination in the theory and practice of chiropody, in accordance with regulation (4) (1) (g) of the Chiropodists Regulations 1967.

 - (i) The Medical Officer of Health.....

- (ii) The Secretary, New Zealand Society of Chiropodists, certifying that he has sighted my registration certificate; or (b) I enclose (such other evidence as the Board may specify).
- 4. (For persons applying under paragraph (d) of Part A of this form):

I enclose particulars of my training and qualifications.

- 5. (For persons applying under paragraph (e) of Part A of this form): I enclose a certificate (or certificates) signed by the person (or persons) by whom I was trained that I have undergone training in chiropody as stated by me and that I have achieved an adequate standard of competence therein.
- 6. (For persons applying under paragraph (f) of Part A of this form): I enclose a certificate of training and a certificate that I have passed the prescribed examination(s).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Chiropodists Regulations 1967. They have the

following effect:

(a) A chiropodist who uses any written matter to advertise his services will be guilty of improper conduct, and liable accordingly to disciplinary action under Part III of the Medical and Dental Auxiliaries Act 1966, unless the form and manner of the advertisement are approved by the Chiropodists Board, either generally or specifically.

(b) No person except a chiropodist or medical practitioner may perform chiropody otherwise than under the "direct supervision" of a chiropodist or medical practitioner. At present, an unqualified person may perform chiropody under the "control and instructions" of a chiropodist or

medical practitioner.

(c) The form of application for registration as a chiropodist is revised.
(d) The definition of "material date" is omitted from the principal regulations as it is no longer needed.

The regulations will come into force on 1 January 1975.
