# THE CUSTOMS REGULATIONS 1968, AMENDMENT NO. 29

#### ORDER IN COUNCIL

At Wellington this 3rd day of October 1988

#### Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL PURSUANT to the Customs Act 1966, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Customs Regulations 1968, Amendment No. 29, and shall be read together with and deemed part of the Customs Regulations 1968\* (hereinafter referred to as the principal regulations).

- (2) Subject to subclause (3) of this regulation, these regulations shall come into force 28 days after the date of their notification in the Gazette.
- (3) Regulations 4 and 5 of these regulations shall come into force on the 1st day of February 1989.
- 2. Fees for officers' time outside working hours—(1) Regulation 14 of the principal regulations (as amended by regulation 3 (1) of the Customs Regulations 1968, Amendment No. 11 and regulation 2 (1) of the Customs Regulations 1968, Amendment No. 25) is hereby amended—
  - (a) By omitting from subclause (1) (a) the expression "\$50.00", and substituting the expression "\$80.00":
  - (b) By omitting from subclause (1) (b) the expression "\$45", and substituting the expression "\$71":
  - (c) By omitting from subclause (2) the expression "\$150", and substituting the expression "\$236".
- (2) Regulation 14 of the principal regulations (as so amended) is hereby further amended by adding the following subclause:
- "(3) The fees prescribed by this regulation are inclusive of goods and services tax under the Goods and Services Tax Act 1985."
- (3) The Customs Regulations 1968, Amendment No. 25 are hereby revoked.
- **3. Customs agent's licence (Individual)**—Regulation 133 (1) of the principal regulations (as substituted by regulation 2 of the Customs Regulations 1968, Amendment No. 4 and amended by regulation 6 of the Customs Regulations 1968, Amendment No. 17) is hereby amended by inserting, after the words "New Zealand Certificate in Customs" the words "or a National Certificate in Business Studies (Customs Option)".
- **4. Licence fee**—(1) Regulation 135 (1) of the principal regulations (as substituted by regulation 6 of the Customs Regulations 1968, Amendment No. 11 and amended by regulation 2 of the Customs Regulations 1968, Amendment No. 26) is hereby amended—
  - (a) By omitting from paragraph (a) the expression "\$165", and substituting the expression "\$264":
  - (b) By omitting from paragraph (b) the expression "\$33", and substituting the expression "\$55".
- (2) Regulation 135 of the principal regulations (as so substituted and amended) is hereby amended by adding the following subclause:
- "(5) The fees prescribed by this regulation are inclusive of goods and services tax under the Goods and Services Tax Act 1985."
- (3) The Customs Regulations 1968, Amendment No. 26 are hereby consequentially amended by revoking regulation 2 (1).
- 5. Customs carriers—(1) Regulation 136 (2) of the principal regulations (as substituted by regulation 7 of the Customs Regulations 1968, Amendment No. 11 and amended by regulation 3 of the Customs Regulations 1968, Amendment No. 26) is hereby amended—
  - (a) By omitting from paragraph (a) the expression "\$165", and substituting the expression "\$264":
  - (b) By omitting from paragraph (b) the expression "\$33", and substituting the expression "\$55".

- (2) Regulation 136 of the principal regulations (as so substituted and amended) is hereby further amended by adding the following subclause:
- "(6) The fees prescribed by this regulation are inclusive of goods and services tax under the Goods and Services Tax Act 1985."
- (3) The Customs Regulations 1968, Amendment No. 26 are hereby consequentially amended by revoking regulation 3 (1).
- **6. Second Schedule**—(1) The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 8 of the Customs Regulations 1968, Amendment No. 28), and substituting the new Second Schedule set out in the Schedule to these regulations.
- (2) The Customs Regulations 1968, Amendment No. 28 are hereby consequentially amended by revoking regulation 8.

#### **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations come into force 28 days after the date of their notification in the Gazette, except for regulations 4 and 5 which come into force on 1 February 1989.

They increase the fees payable in respect of-

- (a) Officers' time outside working hours (regulation 2):
- (b) Customs agents licence (regulation 4):
- (c) Common carriers licence (regulation 5):
- (d) Warehouses licensed for storage of goods for export (regulation 6).
- All these fees are inclusive of goods and services tax.

Regulation 3 extends the granting of Customs agent's licences (Individual) to holders of National Certificates in Business Studies (Customs option).
