## THE COMMERCE REGULATIONS 1975

# DENIS BLUNDELL, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington this 28th day of October 1975

## Present:

THE HON. R. J. TIZARD PRESIDING IN COUNCIL

Pursuant to the Commerce Act 1975, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Commerce Regulations 1975.
- (2) These regulations shall come into force on the 1st day of November 1975.
- 2. Oaths of fidelity and secrecy—The oath of fidelity and secrecy referred to in section 19 of the Commerce Act 1975 shall be in such one of the forms numbered 1, 2, 3, and 4 in the First Schedule hereto, as the case requires.
- 3. Notice of aggregation proposals—The Examiner may from time to time prescribe the form of the notice required to be given under section 67 (1) of the Commerce Act 1975.

# Form 1 Commerce Act 1975

OATH OF FIDELITY AND SECRECY TO BE TAKEN BY MEMBERS OF THE COMMISSION

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 November 1975, prescribe the forms of the oaths of fidelity and secrecy which are required for the purposes of section 19 of the Commerce Act 1975.

These regulations also provide that the form of notice of an aggregation proposal required to be given under section 67 (1) of that Act is to be prescribed by the Examiner of Commercial Practices.

Issued under the authority of the Regulations Act 1936. Date of notification in Gazette: 30 October 1975.

These regulations are administered in the Department of Trade and Industry.
