Pursuant to the Companies Special Investigations Act 1958, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and, in relation to clause 2 hereof, on the advice of the Minister of Justice given on the recommendation of a committee appointed under section 472 of the Companies Act 1955, hereby makes the following order.

#### ORDER

- 1. Title—This order may be cited as the Companies Special Investigations Order 1972.
- 2. Act to apply to certain companies—It is hereby declared that the Companies Special Investigations Act 1958 shall apply to the companies specified in the Schedule to this order.
- 3. Receiver and manager—The first receiver and manager in respect of each company to which this order applies shall be Douglas Leonard Hazard of Auckland, Chartered Accountant.
