### ORDER IN COUNCIL

At Wellington this 22nd day of January 1989

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Companies Special Investigations Act 1958, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, and, in relation to clause 2 hereof, on the advice of the Minister of Justice given on the recommendation of the Securities Commission, hereby makes the following order.

### ORDER

**1. Title and commencement**—(1) This order may be cited as the Companies Special Investigations Order 1989.

(2) This order shall come into force at 6 p.m. on the 22nd day of January 1989.

**2. Act to apply to certain companies**—It is hereby declared that the Companies Special Investigations Act 1958 shall apply to the companies named in the First and Second Schedules to this order.

**3. Receivers and managers**—Frederick Nelson Watson, Bruce Graham Stowell, Gerald Stanley Rea, and Kerry Thomas Stotter, all of Auckland, Chartered Accountants, are hereby appointed receivers and managers in respect of each company to which this order applies.
