

## THE CHRISTCHURCH SECONDARY SCHOOLS REGULATIONS 1966, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 57 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Christchurch Secondary Schools Regulations 1966, Amendment No. 3, and shall be read together with and deemed part of the Christchurch Secondary Schools Regulations 1966\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the the date of their notification in the Gazette.
- 2. Regulations to apply to Rangiora High School—The principal regulations are hereby amended by adding to regulation 3 the following paragraph:

"(o) The Rangiora High School."

3. Board of Governors of Rangiora High School—The principal regulations are hereby further amended by inserting, after regulation 5, the following regulation:

"5A. The Board of Governors of Rangiora High School shall consist

of:

- "(a) One Governor appointed by the Canterbury Education Board:
- "(b) One Governor appointed by the Council of the University of Canterbury:
- "(c) Two Governors appointed by the Old Pupils' Association of the school:
- "(d) Five Governors elected by the parents of the pupils attending the school:
- "(e) One Governor appointed jointly by the Rangiora Borough Council and the Rangiora County Council."

4. Saving—Notwithstanding anything in the principal regulations or in these regulations, the Rangiora High School Board of Governors constituted under the Rangiora High School Act 1881 shall, until the 31st day of March 1976, continue to be the Board of Governors of the Rangiora High School and to exercise control over the school in every way as if, except for the filling of casual vacancies to the Board under section 6 of the Rangiora High School Act 1881 (as amended by section 4 of the Rangiora High School Amendment Act 1960), the Board were a Board of Governors constituted under and for the purposes of the principal regulations as amended by these regulations.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

This amendment to the Christchurch Secondary Schools Regulations 1966 makes provision for the constitution, election, and appointment of a Board of Governors of the Rangiora High School consequent to the school being placed under the Christchurch Secondary Schools Council. A saving provision is included, the effect of which is that the present members together with any other members appointed to fill any casual vacancies of the Board of Governors of the school will continue to function as the Board in control of the school as if the Board were constituted under and for the purposes of the principal regulations as amended by these regulations.
