## ORDER IN COUNCIL

At the Government Buildings at Wellington this 17th day of January 1985

### Present:

THE HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to section 57 of the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Christchurch Secondary Schools Regulations 1976, Amendment No. 1, and shall be read together with and deemed part of the Christchurch Secondary Schools Regulations 1976\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date

of their notification in the Gazette.

**2. Board of Governors of Buller High School**—(1) Regulation 7 of the principal regulations is hereby amended by revoking paragraphs (d) and (e), and substituting the following paragraphs:

"(d) One Governor elected by the members of the school committees of Westport North Primary School, Westport South Primary School,

and St. Canice's Primary School:

"(e) One Governor elected by the members of the school committees of Waimangaroa Primary School and Granity Primary School:".

- (2) Nothing in subclause (1) of this clause shall affect the tenure of the persons immediately before the commencement of these regulations holding office as Governors of Buller High School.
- 3. Future elections to be held under Secondary School Boards Administration and Employment Regulations 1965—Regulations 8, and 10 to 16, of the principal regulations are hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations have 2 effects. First, they alter the composition of the Board of Governors of Buller High School. The Governor at present elected by the members of the school committees of Westport North Primary School and Westport South Primary School is in future to be elected by the members of the school committees of those schools and St. Canice's Primary School. And the Governor at present elected by the members of the school committees of Waimangaroa Primary School and Seddonville Primary School is in future to be elected by the members of the school committees of Waimangaroa Primary School and Granity Primary School. In neither case are Governors at present holding office affected.

Secondly, these regulations revoke those provisions of the principal regulations that specify a particular regime for the election and appointment of the Governors of the schools to which they apply. In future, such elections and appointments are to be in accordance with the general rules specified in the Secondary School Boards Administration and Employment Regulations 1965, and are to occur at the times specified in those regulations.
