ORDER IN COUNCIL

At the Government House at Wellington this 7th day of August 1978

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff (Preferences) Amendment Order 1978.

(2) Except as otherwise provided in subclause (3) of this clause, this order shall be deemed to have come into force on the 1st day of July 1978.

(3) Subclause (2) of clause (2) of this order shall come into force on the day after the date of the notification of this order in the *Gazette*.

2. Tariff amended—(1) The Customs Tariff is hereby amended by revoking the Australian rate of duty in respect of each Tariff item specified in the First Schedule hereto, being the rate of duty shown in the column of the Customs Tariff headed "Preferential Tariff", and substituting in each case the rate of duty or exemption from duty set out opposite that item in the said First Schedule.

(2) The Customs Tariff is hereby further amended by revoking the Normal rate of duty in respect of each Tariff item specified in the Second Schedule hereto, being the rate of duty shown in the column of the Customs Tariff headed "Normal Tariff", and substituting in each case the rate of duty set out opposite that item in the said Second Schedule.

(3) The Customs Tariff is hereby further amended by revoking the United Kingdom rate of duty in respect of Tariff item 87.06.059 specified in the Third Schedule hereto, being the rate of duty shown in the column of the Customs Tariff headed "Preferential Tariff", and substituting the rate of duty set out opposite that item in the said Third Schedule.

3. Consequential revocations—(1) The Customs Tariff (Consolidation) Amendment Order 1978* is hereby amended by revoking so much of the Fifth Schedule as relates to the Australian rates of Customs duty in the column headed "Preferential Tariff" in respect of Tariff items 02.04.000, 74.19.009, 84.40.029, 85.04.009, 85.06.009, 85.12.009, 85.17.009, 85.19.009, 85.19.031, 85.19.051, 85.19.059, and 85.19.079.

(2) The Customs Tariff (Vehicle Parts) Amendment Order 1978† is hereby amended by revoking so much of the Schedule as relates to Tariff item 87.06.059.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

Except for the amendment to the United Kingdom rate of duty in respect of Tariff item 87.06.059 this order is made in terms of an agreement on tariffs and tariff preferences between Australia and New Zealand which entered into force on 1 December 1977.

The order reduces the rates of Customs duty on certain goods from Australia, and in addition increases the Normal Tariff rates of duty for Tariff items 34.03.011 and 90.19.009 to accord Australia a margin of preference. The order also reduces the United Kingdom rate of duty in respect of Tariff item 87.06.059.
