ORDER IN COUNCIL

At the Government House at Wellington this 30th day of June 1980

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 124 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

—

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff (Linen) Amendment Order 1980.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Tariff amended—The portion of the Customs Tariff specified in the First Schedule hereto is hereby revoked and the items, item numbers, rates of duty, exemptions from duty and statistical key specified in the Second Schedule are hereby substituted.

3. Consequential revocations—The Customs Tariff (Textiles) Amendment Order 1980* is hereby amended by revoking so much of the Schedule as relates to Tariff items 62.02.002, 62.02.005, 62.02.011, and 62.02.019.
