PURSUANT to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff (ANZCERTA) Amendment Order 1983.

(2) This order shall come into force on the 1st day of January 1984.

2. Tariff amended—The Customs Tariff is hereby amended by revoking so much of Part I as relates to the rates of duty specified after the expression “Aul” in the column of the Customs Tariff headed “Preferential Tariff”, in respect of each Tariff item specified in the Schedule hereto, and substituting the rates of duty and exemptions from duty set out opposite that item in the said Schedule.

3. Consequential revocations—(1) The Customs Tariff (TEXTILES) Amendment Order 1980* is hereby amended by revoking so much of the Schedule as relates to the “Aul” rates of duty for items 60.02.000 and 61.10.001.

(2) The Customs Tariff (PLASTICS) Amendment Order 1982† is hereby amended by revoking so much of the Schedule as relates to the “Aul” rate of duty for item 39.07.331.

(3) The Customs Tariff (Miscellaneous) Amendment Order 1983‡ is hereby amended by revoking so much of the Schedule as relates to the “Aul” rate of duty for item 60.06.021.

This order provides for normal CER phasing rates for gloves of headings 39.07, 40.13, 42.03, 43.03, 43.04, 60.02, 60.06, and 61.10 of the Tariff.

It also provides for increases in duty rates on certain steel items of heading 73.20.
