ORDER IN COUNCIL

At the Government House at Wellington this 19th day of June 1984

PURSUANT to sections 123 and 124 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

**1. Title and commencement**—(1) This order may be cited as the Customs Tariff (Electronics) Amendment Order 1984.

(2) This order shall come into force on the 20th day of June 1984.

**2. Tariff amended**—The Customs Tariff is hereby amended by revoking so much of Part I as relates to items 85.01.031, 85.13.001, 85.13.009, 85.14.011, 85.14.019, 85.14.021, 85.14.028, 85.14.029, 85.14.039, 85.15.001, 85.15.011, 85.15.021, 85.15.029, 85.15.039, 85.15.049, 85.15.059, 85.16.000, 85.17.001, 85.17.009, 85.19.061, 85.19.069, 85.19.071, 85.19.079, 85.21.001, 85.22.019, 90.28.001, 91.01.001, 91.02.002, 91.04.002, 92.11.001, 92.11.009, and 92.11.019, and substituting the items, rates of duty, exemptions from duty, and statistical key specified in the Schedule to this order.

**3. Revocations**—(1) The Customs Tariff (Consolidation) Amendment Order 1978\* is hereby amended by revoking—

- (a) So much of the Fifth Schedule as relates to items 85.01.031, 85.13.009, 85.16.000, and 85.19.071; and
- (b) So much of the Sixth Schedule as relates to item 85.14.029.

(2) The Customs Tariff (Preferences) Amendment Order 1978† is hereby amended by revoking so much of the First Schedule as relates to items 85.14.019, 85.17.009, and 85.19.079.

## EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which comes into force on 20 June 1984, reinstates in the Customs Tariff the items, rates of duty, exemptions from duty, and statistical key applicable under the Customs Tariff (Electronics) Amendment Order 1983. That order expired on the close of 14 June 1984 (the last day of the session in which it was laid before Parliament). For that order to have continued in force, an Act of Parliament validating or confirming it would need to have been passed during that session.

Section 131 (3) of the Customs Act 1966 requires that any duty, which has been collected under the expired order and which is in excess of the duty otherwise payable, is to be refunded.
