PURSUANT to sections 123, 124, and 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the rates of duty specified in items 40.11.046, 73.13.011, and 73.13.013 of the Customs Tariff are likely to operate in an injurious, unfair, or anomalous manner generally to the public interest and particularly to certain industries carried out in New Zealand, and that it is necessary for the protection of those industries that the duties specified in those items and set out in the Schedule hereto should be imposed, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff (Miscellaneous) Amendment Order 1987.
