

THE CUSTOMS TARIFF AMENDMENT ORDER (NO. 7) 1973

Pursuant to section 10E of the Tariff and Development Board Act 1961 and section 124 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the rates of duty specified in the First Schedule hereto, being rates specified in the Customs Tariff, are likely to operate in an injurious, unfair, or anomalous manner in respect of an industry carried on in New Zealand, and that it is necessary for the protection of that industry that the duties set out in the Second Schedule hereto should be imposed, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Customs Tariff Amendment Order (No. 7) 1973.
- (2) This order shall come into force on the day after the date of its notification in the Gazette.
- 2. Portion of Tariff suspended—The portion of the Customs Tariff specified in the First Schedule hereto is hereby suspended.
- 3. Duties imposed—The duties set out in the Second Schedule hereto are hereby imposed.
- 4. Consequential revocations—The Customs Tariff Amendment Order (No. 6) 1972* is hereby amended by revoking so much of the Second Schedule as relates to items 39.02.081 and 59.10.011.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order makes provision for temporary increases in the rates of Customs duty on certain floor coverings falling within headings 39.02 and 59.10 of the Customs Tariff. The increases were recommended by the Emergency Protection Authority.
