ORDER IN COUNCIL

At the Government Buildings at Wellington this 13th day of April 1970

Present:

THE HON. N. L. SHELTON PRESIDING IN COUNCIL

Whereas by the Customs Tariff Amendment Order (No. 3) 1969*, made pursuant to section 10£ of the Tariff and Development Board Act 1961 and section 124 of the Customs Act 1966, the portions of the Customs Tariff specified in the First Schedule to that order were suspended and the duties and exemptions from duty specified in the Second Schedule to that order were temporarily imposed and created on the recommendation of the Emergency Protection Authority: And whereas the temporary duties imposed by that order and specified in the First Schedule to this order are now included in the Second Schedule to the Customs Tariff Amendment Order (No. 4) 1970†: And whereas the Tariff and Development Board has since recommended that those temporary duties should be revoked:

Now therefore, pursuant to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the revocation of the temporary duties specified in the First Schedule to this order is necessary in furtherance of the public interest, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff Amendment Order (No. 8) 1970.

(2) This order shall come into force on the day after the date of its notification in the Gazette.

- 2. Tariff amended—The Customs Tariff is hereby amended by revoking the items and rates of duty specified in the First Schedule hereto, and substituting the items and rates of duty specified in the Second Schedule hereto.
- **3. Revocation**—The Customs Tariff Amendment Order (No. 4) 1970† is hereby amended by revoking so much of the Second Schedule as relates to items 82.04.76 and 82.04.79.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order revokes the temporary additional rates of Customs duty first imposed by the Customs Tariff Amendment Order (No. 3) 1969 on pressure force feed oil cans of capacities not exceeding 1½ pints, and reinstates the original rates of duty on those goods from British Preferential, Most Favoured Nation, and General sources. The margin between the Australian and British Preferential rates of Customs duty on those goods has been eliminated.
