WHEREAS by the Customs Tariff (Bars and Rods, Hard Chromed) Amendment Order 1974*, made pursuant to section 10E of the Tariff and Development Board Act 1961 and section 124 of the Customs Act 1966, the duties and exemptions from duty specified in the Schedule to that order were temporarily reimposed and re-created on the recommendation of the Tariff and Development Board: And whereas the said temporary duties and exemptions from duty are now included in the Customs Tariff by the Customs Tariff (Consolidation) Amendment Order 1974† made pursuant to section 11 of the Customs Acts Amendment Act 1974 and section 124 of the Customs Act 1966: And whereas the Tariff and Development Board has since recommended that the temporary duties so imposed should be revoked:

Now therefore, pursuant to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and being satisfied that the revocation of the temporary duties specified in the Schedule to the said order is necessary in furtherance of the public interest, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Customs Tariff (Bars and Rods, Hard Chromed) Amendment Order (No. 2) 1974.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Tariff Amended—The Customs Tariff (as set out in the First Schedule to the Customs Acts Amendment Act 1974 and amended by the Customs Tariff (Consolidation) Amendment Order 1974†) is hereby amended by revoking the items, rates of duty, and exemptions from duty specified in the First Schedule hereto, and substituting the item, rates of duty, and exemptions from duty specified in the Second Schedule hereto.

3. Consequential Revocation—The Customs Tariff (Consolidation) Amendment Order 1974† is hereby amended by revoking so much of the Second Schedule as relates to Tariff items 73.10.201 and 73.10.209.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order revokes the temporary increases in the rates of Customs duty on hard chromed bars and rods falling within heading 73.10 of the Customs Tariff.

The temporary increases were originally imposed by the Customs Tariff Amendment Order (No. 3) 1973, and were subsequently reimposed by the Customs Tariff (Bars and Rods, Hard Chromed) Amendment Order 1974.
