PURSUANT to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

**1. Title and commencement**—(1) This order may be cited as the Customs Tariff (Developing Country) Amendment Order 1979.

(2) This order shall come into force on 1 November 1979.

**2. Tariff amended**—(1) The Customs Tariff is hereby amended by revoking the items, rates of duty, and statistical key specified in the First Schedule hereto, and substituting the items, rates of duty, and statistical key specified in the Second Schedule hereto.

(2) The Customs Tariff is hereby further amended by revoking the Developing Country duty rates specified in the Third Schedule hereto, and inserting those specified in the Fourth Schedule hereto.
