## THE CITRUS TREES DISEASES REGULATIONS 1961

# COBHAM, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 12th day of July 1961

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Orchard and Garden Diseases Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. (1) These regulations may be cited as the Citrus Trees Diseases Regulations 1961.

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. Except with the consent of the Director-General of Agriculture, no person shall remove or cause to be removed any citrus plant (other than citrus fruit), or any citrus seed intended for propagation, or any plant capable of being used as a root stock for citrus plants, from—

- (a) Any place in New Zealand to any place in the Borough of Wairoa or in the Counties of Bay of Islands, Whangarei, Tauranga, Cook, and Wairoa:
- (b) Any place in New Zealand outside the area specified in this paragraph into that area, being the area that consists of the Provincial District of Auckland exclusive of the Counties of Bay of Islands, Whangarei, Tauranga, and Cook, and the part of the County of Wairoa that lies within the Provincial District of Auckland.

**3.** Notwithstanding anything to the contrary in regulation 2 of these regulations, the consent of the Director-General of Agriculture shall not be required for the removal of any citrus plant, or any citrus seed intended for propagation, or any plant capable of being used as a root stock for citrus plants, from—

(a) Any place in the Borough of Wairoa to any place in any of the Counties of Bay of Islands, Whangarei, Tauranga, Cook, and Wairoa: 1961/78

- (b) Any place in any of the Counties of Bay of Islands, Whangarei, Tauranga, Cook, and Wairoa to any place in any other of those Counties or in the Borough of Wairoa:
- (c) Any place in the Borough of Wairoa or in the Counties of Bay of Islands, Whangarei, Tauranga, Cook, and Wairoa to any place in the area specified in paragraph (b) of regulation 2 of these regulations.

4. The Citrus Trees Diseases Regulations 1959\* are hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations extend the provisions which formerly appeared in the Citrus Trees Diseases Regulations 1959 so as to impose further restrictions on the introduction of citrus plants, seeds, and root stocks into the Borough of Wairoa and the Counties of Bay of Islands, Whangarei, Tauranga, Cook, and Wairoa.
