ORDER IN COUNCIL

At the Government House at Wellington this 10th day of May 1976

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 125 of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

**1. Title and commencement**—(1) This order may be cited as the Customs Tariff (Pacific Islands) Amendment Order 1976.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

**2. Tariff amended**—Part II of the Customs Tariff is hereby amended by revoking reference number 35.0, and the description and rates of duty to which this number relates, and substituting the reference number, description, and rates of duty specified in the Schedule hereto.

**3. Consequential revocation**—The Customs Tariff (Consolidation) Amendment Order 1974\* is hereby amended by revoking all reference to the Third Schedule.

EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order amends the Customs Tariff (Part II reference 35.0) to accord concessionary entry of hand-made products under the Pacific Islands Handicraft Scheme to Tuvalu and the Gilbert Islands including Ocean Island, the Phoenix Islands, the Northern Line Islands (Washington, Fanning, and Christmas), and the Central and Southern Line Islands (Flint, Caroline, Vostock, Malden, and Starbuck), the British Solomon Islands, Pitcairn Island, and the New Hebrides Condominium.
