**THE CATTLE TUBERCULOSIS REGULATIONS 1962,  
AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government House at Wellington this 15th day of June 1966

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Stock Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Cattle Tuberculosis Regulations 1962, Amendment No. 2, and shall be read together with and deemed part of the Cattle Tuberculosis Regulations 1962\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Regulation 3 of the principal regulations is hereby amended by inserting in subclause (1), after the words "the said subsection (3)", the words "or dies before slaughter within the period so notified".

3. Regulation 3 of the principal regulations is hereby further amended by adding to subclause (1) the following proviso:

"Provided further that compensation shall be payable, in respect of any animal which has passed a tuberculin test and is subsequently condemned as a clinical case of tuberculosis before the next tuberculin test of the whole of the herd of which it forms part, as if the animal had been a reactor."

4. Regulation 3 of the principal regulations is hereby further amended by inserting in subclause (2), after the words "take place", the words "or where any cattle has been directed to be slaughtered by the Director-General under the said subsection (3) but dies before slaughter outside the period within which the slaughter was required to take place".

5. Regulation 3 of the principal regulations is hereby further amended by inserting in subclause (2), after the word "slaughter" where it last appears, the words "or death".

6. The principal regulations are hereby further amended by revoking regulation 4.

7. Regulation 10 of the principal regulations is hereby amended by inserting in subclause (2), after the word "slaughter", the words "or death".

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations vary the rules governing the payment of compensation in respect of condemned animals which die before slaughter, and in respect of animals which pass a tuberculin test and are subsequently condemned as clinical cases of tuberculosis before the next test of the whole herd.
