**THE DRAINAGE AND PLUMBING EXTENSION CONSOLIDATION  
NOTICE 1941.**

Department of Health,  
Wellington, 17th March, 1941.

PURSUANT to section 133 of the Health Act, 1920, and pursuant to regulations made under that Act on the 3rd day of September, 1923, and to be cited as the Drainage and Plumbing Regulations, I, Arnold Henry Nordmeyer, Minister of Health, hereby give notice as follows :—

1. This notice may be cited as the Drainage and Plumbing Extension Consolidation Notice 1941.

2. The respective notices relating to the Drainage and Plumbing Regulations and referred to in the First Schedule hereto are revoked.

3. The Drainage and Plumbing Regulations are applied to the respective parts of New Zealand named in the first column of the Second Schedule hereto, as from the respective dates set out in the second column of the said Second Schedule.

the southern corner of Section 249, Parish of Puniu; thence in a northerly direction along the southern boundaries of Sections 251 and 254 and the western boundary of Section 255 to and across the Te Awamutu to Pirongia Main Highway; thence along the said main highway and the north-western boundary of Section 316, Block 2, Puniu Survey District, across the Mangapiko Stream to the western boundary of Lot 28 on Deposited Plan No. 20888, Auckland Registry; thence north-easterly along the northern boundary of the last-mentioned Lot 28 to and across Meadways - Te Awamutu Main Road; thence south-easterly to the junction of the said road with Ngaroto Road; thence along the northern boundary of the last-mentioned road to and across the Hamilton - Te Kuiti State Highway and along Te Rahu Road to a point opposite the eastern boundaries of Lots 1 and 2, Deposited Plan No. 19273, Auckland Registry; thence southerly along the eastern boundaries of the said Lots 1 and 2 to and in an easterly direction along the northern boundary of all land on Deposited Plan No. 20366; thence easterly and southerly along the northern and eastern boundaries of Lot 31 on Deposited Plan No. 20887, Auckland Registry, to a public road; thence in an easterly direction intersecting Bonds and Te Rahu Roads to a point opposite the eastern boundary of Part Lot 3, Deposited Plan No. 9070, Auckland Registry; thence southerly across a public road and along the eastern boundaries of Lots Part 3 and 2 of the said Deposited Plan No. 9070 to and across the Te Awamutu to Cambridge Main Highway to the north-eastern boundary of Section 122, Block VII, Puniu Survey District; thence along the north-eastern and southern boundaries of the said Section 122 and the southern boundary of Section 126 to the Mangahoe Stream; thence in an easterly direction along the north bank of the said stream to a public road forming the southern boundary of Section 17, Block VII, Puniu Survey District; thence southerly to and across a public road and along the eastern boundaries of Part Section 15, Deposited Plan No. 984, and Part Section 15, Deposited Plan No. 7471, and Section 343, Block VII, Puniu Survey District, to and across the Kihikihi-Arapuni Main Highway to the northern boundary of all land on Deposited Plan No. 13386, Auckland Registry; thence easterly, southerly, and westerly along the boundaries of the last-mentioned land and the southern boundary of Section 342, Block VII, Puniu Survey District, to the place of commencement.

## APPENDIX II.

### PARTS OF THE COUNTY OF MARLBOROUGH.

THOSE portions of the County of Marlborough which comprise—

First, all that area in the Marlborough Land District bounded on the north by the southern side of Old Renwick Road from the north-western corner of the Original Section No. 51, Omaka District, to the north-western corner of Original Section No. 54, Omaka District; thence southerly along the western boundary of Original Sections 54 and 9, Omaka District, to the Omaka River; thence down the left bank of the Omaka River to the western boundary of the Borough of Blenheim; thence northerly along the western boundary of the Borough of Blenheim to the north-western corner of Original Section 51, Omaka District, to the point of commencement.

Secondly, all that area in the Marlborough Land District bounded by a line commencing at the south-western corner of the Borough of Blenheim; thence southerly along the western boundary of Original Section 27, Omaka District, to Taylor Pass Road; thence north-easterly along the north-western side of Taylor Pass Road to a point in line with the northern side of Hospital Road; thence along the northern side of Hospital Road to the eastern side of Howick Road; thence southerly along the northern side of Wither Road to the south-eastern corner of Section 111 of Original Section 43, Opawa District; thence northerly along the eastern boundary of Sections 111, 88, 87, and 63, all of Original Section 43, Opawa District, to the north-eastern corner of Section 63 aforesaid; thence northerly along the production of the eastern boundary of the said Section 63 to Alabama Road; thence along a right line to the south-eastern corner of Section 13, of Original Section 45, Opawa District; thence along the eastern boundary of Sections 13, 10, 11, 12, 13, and 14, all of Original Section 45, Opawa District, to Stephenson Street; thence to and along the western side of Stuart Street to the boundary of the Borough of Blenheim; thence westerly, southerly, and westerly along the borough boundary to the south-western corner of the said borough to the place of commencement.

APPENDIX III.

PARTS OF THE COUNTY OF SOUTHLAND.

THE plans referred to in this Appendix are the plans deposited in the Head Office of the Department of Health at Wellington marked H. 38/67 and bearing the respective distinguishing letters from "A" to "M" consecutively (both inclusive), hereinafter referred to, copies of the said plans being deposited in the office at Invercargill of the Southland County Council and the office at Gore of the Department of Health.

(1) *Otatara*.—The area shown edged red on plan marked "A," and bounded as follows: Commencing at the north-western corner of Lot 1, L.T.P. 568, situated in Block XX, Invercargill Hundred; thence in an easterly direction along the southern boundary of Blocks XVII and XXI, Invercargill Hundred, to a point in line with the eastern side of Section 10, Block XXI aforesaid; thence in a northerly direction to and along the eastern boundary of the said Section 10 and westerly along the northern boundary of the said Section 10 to the eastern boundary of Section 11, Block XXI aforesaid; thence in a northerly direction along the eastern boundary of the said Section 11 to the north-eastern corner thereof; thence in a north-easterly direction along the south-eastern boundary of Part Section 6, Block XXI aforesaid, and that boundary produced to and across Marama Avenue; thence in a north-westerly direction along the north-eastern side of the said Marama Avenue to a public road forming the southern boundary of Section 4, Block XXI aforesaid; thence in an easterly direction along the southern side of the said public road to a public road forming the western boundary of Section 19, Block XXI aforesaid; thence in a south-easterly direction along the south-western side of the said public road to the north-eastern corner of Lot 31, L.T.P. 1636; thence in a south-westerly direction along the north-western boundary of the said Lot 31 to and across a right-of-way; thence in a south-easterly direction along the south-western side of the said right-of-way to a public road; thence in a south-westerly direction along the north-western side of the said public road to a point in line with the south-western boundary of Lot 90, L.T.P. 1045; thence by a right line to and along the south-western boundary of said Lot 90 to the north-western boundary of Section 8, Block XX aforesaid; thence in a south-westerly direction along the north-western boundary of the said Section 8 to a public road; thence in a north-westerly direction along the north-eastern side of the said public road to the northern side of Taiapa Road; thence in a westerly direction along the northern side of a public road to and across a public road forming the western boundary of Section 85, Block XX aforesaid; thence in a southerly direction along the western side of the said public road to a public road forming the northern boundary of Section 84, Block XX aforesaid; thence in a westerly direction along the northern side of the said public road to a public road along the bank of the Oreti River; thence in a northerly direction along the eastern side of the said public road which forms the western boundary of Lots 76, 75, 74, 73, 72, 71, 70, 69, 68, 67, 66, 65, 12, 11, and 6, L.T.P. 1785, and Lot 1, L.T.P. 568, to the point of commencement.

(2) *Grassmere, Collingwood, Waikiwi, Prestonville, and other Lands in the Vicinity*.—The area shown edged red on plan marked "B," and bounded as follows: Commencing at a point on the eastern boundary of Section 5, Block XV, Invercargill Hundred, the said point being the intersection of the said boundary and the north side of Bay Road; thence in a northerly direction along the eastern boundary of the said Section 5 to the north-eastern corner thereof; thence in an easterly direction along the southern boundary of Section 1, Block XV aforesaid, to the eastern side of the Invercargill-Kingston Railway Reserve; thence in a northerly direction along the eastern side of the said Invercargill-Kingston Railway Reserve to the West Plains Road; thence in an easterly direction along the southern side of West Plains Road to and across the Main North Road; thence in a northerly direction along the eastern side of the Main North Road to a public road forming the south boundary of Section 27, Block IV, Invercargill Hundred; thence in an easterly direction along the southern side of the said public road to the western boundary of Section 15, Block IV aforesaid; thence in a southerly direction along the western boundary of the said Section 15 to a point 500 links north of Bainfield Road; thence in an easterly direction by a right line 500 links distance from and parallel to the said Bainfield Road to a point in line with the western side of Elles Road; thence in a southerly direction by a right line to and along the western side of the said Elles Road, to the north-eastern corner of Part



Section II (scenic reserve), Block IV aforesaid, the said point being approximately 520 links north of the Waihopai River; thence in a westerly direction generally along the north-eastern boundary of the said Part Section II and the north-western boundary of Lot 1, L.T.P. 2485, to the western boundary of Section II, Block IV aforesaid; thence in a southerly direction along the western boundary of the said Section II to the south-western corner thereof; thence in a westerly direction generally along the northern side of a public-road reserve, across the Main North Road and along the southern boundary of Sections 27 and 2 to the Invercargill-Kingston Railway Reserve; thence by a right line to the eastern corner of Section 117, Block XV aforesaid; thence in a north-westerly direction along the north-eastern boundary of the said Section 117 to the eastern boundary of Section 30, Block XV aforesaid; thence in a northerly direction along the eastern boundary of Sections 30 and 4 to and across Bay Road; thence in a north-westerly direction along the northern side of the said Bay Road to the point of commencement.

north-eastern boundary of the said Section 78 and Sections 79, 80, and 81, Block III aforesaid; thence in a south-westerly direction along the south-eastern boundary of the said Section 81 to a point in line with the north-eastern boundary of Section 82, Block III aforesaid; thence in a south-easterly direction by a right line across a public road to and along the north-eastern boundary of the said Section 82 and Sections 83, 84, 85, 86, 87, 88, 89, 90, and 91, Block III aforesaid; thence in a south-westerly direction along the south-eastern boundary of the said Section 91 by a right line across a public road to the easternmost corner of Section 48A, Block III aforesaid; thence in a south-westerly direction along the south-eastern boundaries of the said Section 48A and Sections 49, 48, 98, 115, and 117, Block III aforesaid, to the southernmost corner of the said Section 117; thence in a north-westerly direction to and along the north-eastern boundary of Section 46, Block III aforesaid, across a public road and along the north-eastern boundaries of Section 41, and Lot 1, D.P. 2224, Block III aforesaid, to a public road; thence along the south-eastern side of the said public road to a point in line with the south-western boundary of Section 65, Block III aforesaid; thence in a north-westerly direction across the said public road to and along the said south-western boundary of Section 65; thence in a north-easterly direction along the north-western boundaries of the said Section 65 and Section 67, Block III aforesaid, to a public road; thence in a south-easterly direction along the south-western side of the said public road to a point in line with the south-eastern boundary of Section 102, Block III aforesaid; thence in a north-easterly direction across the said public road to and along the said south-eastern boundary of Section 102 to the point of commencement.

(12) All that area shown edged red on plan marked "G," situate in Block XIII, Waiiau Survey District, and Block XVII, Longwood Survey District, and bounded as follows: Commencing at a point on the left bank of the Waiiau River in line with the north-eastern boundary of Section 34, Town of Tuatapere Extension No. 2; thence in a south-easterly direction across Alton Terrace, and along the north-eastern boundary of the said Section 34 to and across Orauca Road and a railway reserve, and along the north-eastern boundary of Section 64, Town of Tuatapere Extension No. 2, and that line produced to Boundary Creek; thence in a south-westerly direction along the said Boundary Creek to a point in line with the eastern boundary of Section 67, Town of Tuatapere Extension No. 2; thence in a southerly direction by a right line to and along the said eastern boundary of Section 67 and along the eastern boundaries of Sections 74, 75, 76, 77, 78, and 79, Town of Tuatapere Extension No. 2, and a public road; thence in a westerly direction along the northern boundary of Block XVII, Longwood Survey District, to and across a railway reserve; thence in a south-westerly and south-easterly direction along the north-western and south-western sides of the said railway reserve, and by a right line across a public road; thence in a southerly direction along the western side of the said railway reserve to a point in line with the southern boundary of Lot 14, D.P. 1398; thence in a westerly direction across the Main Road and along the said southern boundary of Lot 14; thence in a northerly direction along the western boundary of the said Lot 14, and Lots 13, 12, 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, and 1, D.P. 1398, and the said western boundary of Lot 1 produced to and along the western boundaries of Lots 7 and 8, D.P. 1100, and Lot 1, D.P. 1014; thence in a westerly and northerly direction along the southern and western boundaries of Lot 2, D.P. 1014; thence in a westerly direction along the southern boundary of Lot 14, D.P. 1405; thence in a northerly direction along the western boundary of the said Lot 14, and Lot 15, D.P. 1697, to Boundary Creek; thence in a south-westerly direction generally along the said Boundary Creek to the Waiiau River; thence in a north-easterly direction generally across the said Boundary Creek and along the said Waiiau River to the point of commencement.
