**THE DRAINAGE AND PLUMBING EXTENSION NOTICE 1941,
NO. 3.**

Department of Health,
Wellington, 10th December, 1941.

PURSUANT to section 133 of the Health Act, 1920, and pursuant to regulations made under that Act on the 3rd day of September, 1923, and to be cited as the Drainage and Plumbing Regulations, I, Arnold Henry Nordmeyer, Minister of Health, hereby give notice as follows:—

1. This notice may be cited as the Drainage and Plumbing Extension Notice 1941, No. 3.

2. This notice shall take effect as from the 15th day of December, 1941.

3. The Drainage and Plumbing Extension Order 1941, No. 2* is revoked.

4. The Drainage and Plumbing Regulations† aforesaid are hereby applied to that portion of the County of Taumarunui hereinafter described and to the Borough of New Plymouth.

5. The Drainage and Plumbing Extension Consolidation Notice 1941‡ is accordingly amended as follows:—

(a) Part I of the Second Schedule thereto is amended by inserting therein, next following the reference to the Borough of Inglewood under the heading "*Taranaki Health District*", the following additional item—

"New Plymouth 15th December, 1941:"

(b) Part III of the said Second Schedule is amended by inserting therein, next following the reference to portions of the Rotorua County under the heading "*South Auckland Health District*", the following additional item—

"That portion of the Taumarunui County described in Appendix I hereto 1st September, 1941".

(c) The said Second Schedule is further amended by inserting therein, next before Appendix II thereof, the following Appendix.

APPENDIX I.

PART OF THE COUNTY OF TAUMARUNUI.

ALL that area in the Taranaki Land District commencing at the northernmost corner of Ohura South N 2E 1A 1 Block and proceeding south-easterly along the northern boundary of the said block produced to the middle of the Ongarue River; thence generally southerly along the middle of the said river to a point in line with the south-west boundary of Ohura South N 2E 1A 4 Block; thence north-westerly in that line to and along the said boundary to the Kururau Road; thence generally westerly along the south side of the said road a distance of 950·1 links; thence north-westerly by a right line to the south-west corner of Ohura South N 2E 3G 2B Block; thence northerly along the western boundary of this block to its north-western corner; thence westerly along the northern boundaries of Ohura South N 2E 3G 2C and 2E Blocks to the south-western corner of Ohura South N 2E 3G 3 11A No. 5 Block; thence northerly along the western boundary of this block to its north-western corner; thence north-easterly along a right line to the northernmost corner of Ohura South N 2E 1A 1 Block, the point of commencement.
